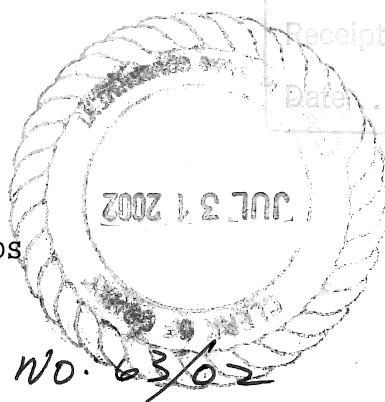

APPLICATION FOR GRANT OF PROBATE OF A WILL

I, JACOBUS GIJSBERT HOLLANDER of P.O. Box 486, George Town, Grand Cayman MAKE OATH and SAY that I believe the paper writing now produced to and marked by me, and exhibited hereto marked "JGH 1", to contain the last will and testament of the late EILEEN BRENDA HOLLANDER-MOODY of George Town, Grand Cayman who died on the 27th May 2001 and whose death certificate is exhibited hereto marked "JGH 2"; that on the 10th July 2002 it was ordered by the Honourable Mr. Justice Graham in the Order exhibited hereto marked "JGH 3", that I be permitted to apply for a grant of probate to the estate of Eileen Brenda Hollander-Moody and that special leave be granted for such application notwithstanding that such application be made outside the time limit of six months from the date of death prescribed by s.4 of the Succession Law (1995 Revision) and further that the force and validity of the last will and testament of the said deceased be pronounced as contained in a copy thereof and that the said will and testament be admitted to proof as contained in the said copy; that I am one of the executors named in the said will, the other executor named in the said will, Christopher Hollander, having renounced probate; that I hereby apply for a grant of probate of the will to me and I enclose my affidavit in that behalf and I undertake that in the event of such grant being made to me:-

- (1) within six months of the grant to me of probate of the said will I will prepare a true inventory of the said estate and exhibit and file the same in the Probate Registry; and
- (2) within one year of such grant to me I will administer the said estate according to the tenor of the will and directions, if any, of the Court and file in the Probate Registry a general accounting for the whole of the assets of the said estate.
