Within fourteen (14) days after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, PO Box 495 GT, Grand Cayman, Cayman Islands, the accompanying Acknowledgement of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgement may be entered against you forthwith without further notice.

STATEMENT OF CLAIM

1. The Plaintiff is a company incorporated pursuant to the laws of the Cayman Islands and carries on business in the Cayman Islands as a specialist in the installation of floors. The Registered Office of the Plaintiff is P.O. Box 10154 APO, Grand Cayman, Cayman Islands.
2. The Defendant is a company incorporated pursuant to the laws of the Cayman Islands and carries on business as a construction company. The Registered Office of the Defendant is in care of International Corporation Services Ltd P.O. Box 472 GT, Grand Cayman, Cayman Islands.
3. In 2000 and 2001 the Defendant contracted with the Plaintiff for the Plaintiff to do various construction works on the construction project known as the Corporate Cayman Center and to supply goods and/or services on certain other sites.
4. Pursuant to the contracts the Plaintiff completed the construction works and supplied goods and services and invoiced the Defendant. In Breach of the contracts the Defendant has failed to pay the Plaintiff the sums due under the contracts. As a result the Plaintiff has suffered loss and damage.

Particulars

The total sum due is CI\$ 29,543.54

5. The Defendant has admitted that the sum of CI\$ 19,859.34 is due and owing to the Plaintiff from the Defendant. This figure was confirmed by the Defendant as due to the Plaintiff in a letter written from the Defendant to the Plaintiff dated the 31st of July 2001.
6. In addition to the principle sum due the Plaintiff also claims interest at the contractual rate of 18% per annum. That interest presently amounts to CI\$ 1,602.70 and is increasing at a per diem rate of CI\$ 14.57.
7. Alternatively, the Plaintiff claims interest pursuant to the Judicature Law (1995 Revision) and Judgment Debts (Rates of Interest) Rules as prescribed from time to time. That interest presently amounts to CI\$ 400.40 and is increasing at a per diem rate of CI\$ 3.64.

AND THE PLAINTIFF claims

- i) CI\$ 29,543.54;
- ii) Contractual interest in the amount of CI\$ 1,602.70 and increasing at a per diem rate of CI\$ 14.57;
- iii) Alternatively, interest pursuant to the Judicature Law (1995 Revision) in the amount of CI\$ 400.40 and increasing at a per diem rate of CI\$ 3.64.
- iii) Costs to be taxed if not agreed.

This Statement of Claim was filed by Broadhurst DaCosta, Attorneys-at-Law for the Plaintiff, whose address for service is 40 Linwood Street, P.O. Box 2503 GT, George Town, Grand Cayman, Cayman Islands, British West Indies.

INDORSEMENT

The amount claimed in respect of the debt or demand is CI\$ 29,543.54 as principal and CI\$ 1,602.70 as interest until the issue of the writ of summons for a total amount of CI\$ 31,146.24. The amount of the fixed costs is CI\$ 500.00 and the costs of issuing the Writ of Summons is CI\$ 150.00 plus the ad valorem fee of CI\$ 195.44. If within the time for returning the acknowledgement of service, the Defendant pays the Plaintiff or its Attorneys-at-Law the total amount claimed in principal and interest, the fixed costs and the costs of issuing the Writ of Summons, further proceedings will be stayed. The money must be paid to the Plaintiff or to its Attorneys-at-Law.

STATEMENT REGARDING INTEREST

- i. The rate of interest claimed under the contracts is at the rate of 18 percent a year;
- ii. The date from which the interest accrued is from the 25th of April 2002;
- iii. The total interest claimed at the date of issue of the Writ of Summons is CI\$ 1,602.70
- iv. The amount of interest accruing each day following the issue of the Writ of Summons is CI\$ 14.57.
- v. Alternatively, the prescribed rate of interest is pursuant to the Judicature Law (1995 Revision) and the Judgment Debts (Rates of Interest) Rules. The relevant interest rate is 4.5% a year which from the 25th of April 2002 to the date of issuance of the Writ of Summons which amounts to CI\$ 400.40 of interest and the amount of interest accruing each day following the issue of the Writ is CI\$ 3.64.

**DIRECTIONS FOR ACKNOWLEDGEMENT OF SERVICE
OF WRIT OF SUMMONS**

1. The accompanying form of *Acknowledgement of Service* should be completed by an Attorney acting on behalf of the Defendant or by the Defendant if acting in person.

After completion it must be delivered or sent by post to the Law Courts, PO Box 495, George Town, Grand Cayman.

2. A Defendant who states in his Acknowledgement of Service that he intends to contest the proceedings *must also serve a defence* on the Attorney for the Plaintiff (or on the Plaintiff if acting in person).

If a Statement of Claim is endorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2). The defence must be served within fourteen (14) days after the time for acknowledging service of the Writ, unless in the meantime a summons for judgment is served on the Defendant.

If the Statement of Claim is not endorsed on the Writ, the defence need not be served until fourteen (14) days after a Statement of Claim has been served on the Defendant.

If the Defendant fails to serve his defence within the appropriate time, the Plaintiff may enter judgment against him without further notice.

3. A *Stay of Execution* against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgement is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to question 3 in the Acknowledgment of Service, that he intends to apply for a stay, execution will be stayed for fourteen (14) days after his Acknowledgement, but he must, within that time, *issue a Summons* for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by installments or otherwise.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgement of Service and return it to the Courts Office.
2. For the purpose of calculating the period of fourteen (14) days for acknowledging service, a Writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (*the name stated on the Writ of Summons*)".
4. Where the Defendant is a FIRM and an Attorney is not instructed, the form must be completed by a PARTNER by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual TRADING IN A NAME OTHER THAN HIS OWN, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a LIMITED COMPANY the form must be completed by an Attorney or by someone authorized to act on behalf of the Company, but the Company can take no further steps in the proceedings without an Attorney acting on its behalf.
7. Where the Defendant is a MINOR or a MENTAL HEALTH PATIENT, the form must be completed by an Attorney acting for a guardian *ad litem*.
8. A Defendant acting in person may obtain help in completing the form at the Courts Office.
