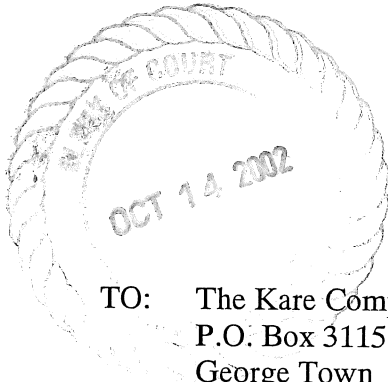

## STATEMENT OF CLAIM

---

1. Pursuant to a written contract dated September 19, 1997 between the Plaintiff and the Defendant, the Plaintiff's claim is for CI\$3257.22 being the balance of the agreed price for the services of the planning, production and telecasting of the Defendant's commercials by the Plaintiff between October 31, 1997 and March 31, 1998 for which the Defendant has refused or otherwise failed to pay the Plaintiff.

### PARTICULARS

As to the planning, production and telecasting of the Defendant's commercials between the said dates the full particulars of these were set out in the Plaintiff's invoices to the Defendant numbered #9690, #10430, #10660, #10853, and #10924.


2. In addition the Plaintiff claims pre-judgment and post-judgment interest as prescribed by the Judicature Law (1995 Revision) and the Judgment Debts (Rates of Interest) Rules. The calculation of the yearly interest was prescribed at a rate of 7.875% from March 31, 1998 to December 31, 1998, and then at a rate of 7% from January 1, 1999 to March 31, 2000, and then at a rate of 8% from April 1, 2000 to May 30, 2001 and then at a rate of 6.25% from June 1, 2001 to November 31, 2001 and then at a rate of 4.5% from December 1, 2001 to the present. The total interest as of October 10, 2002 amounts to CI\$1003.31 increasing at a per diem rate of CI\$0.40.

AND THE PLAINTIFF claims:

1. CI\$3257.22 due under the contract;
2. In addition, pre-judgment and post-judgment interest upon the said damages pursuant to the Judicature Law (1995 Revision) amounting to CI\$1003.31 as at October 10, 2002 and increasing at a per diem rate of CI\$0.40; and
3. Costs to be taxed if not agreed.

### **INDORSEMENT**

The amount claimed in respect of the debt is CI\$3257.22 as principle and CI\$1003.31 as interest as of October 10, 2002 for a total amount of CI\$4257.53. The present rate of interest is prescribed by the Judicature law (1995 Revision) and is 4.5%. The above debt is increasing at a rate of CI\$0.40 per diem. The amount of the fixed costs is CI\$250.00 and the costs of issuing the Writ of Summons is CI\$150.00. If within the time for returning the Acknowledgement of Service, the Defendant pays the Plaintiff or its Attorneys-at-Law the total amount claimed in principal and interest, the fixed costs and the costs of issuing the Writ of Summons, further proceedings will be stayed. The money must be paid to the Plaintiff or to its Attorneys-at-Law.

### **STATEMENT REGARDING INTEREST**

1. The prescribe rates of interest pursuant to the Judicature law are as follows
  - a. From March 31, 1998 to December 31, 1998 the prescribed rate of interest was 7.875%. This amounts to a total interest for this period of CI\$192.50;
  - b. From January 1, 1999 to March 31, 2000 the prescribed rate of interest was 7%. This amounts to a total interest for this period of CI\$282.10;
  - c. From April 1, 2000 to May 31, 2001 the prescribed rate of interest was 8%. This amounts to a total interest for this period of CI\$302.46;
  - d. From June 1, 2001 to November 31, 2001 the prescribed rate of interest was 6.25%. This amounts to a total interest for this period of CI\$100.65; and
  - e. From April 30, 2002 to the present the prescribed rate of interest was 4.5%. This amounts to a total interest for this period of CI\$121.60.
  
2. The total amount of interest claimed pursuant to the Judicature Law as of October 10, 2002 is CI\$1003.31 increasing at CI\$.40 per diem.

If the Statement of Claim is not endorsed on the Writ, the defence need not be served until fourteen (14) days after a Statement of Claim has been served on the Defendant.

If the Defendant fails to serve his defence within the appropriate time, the Plaintiff may enter judgment against him without further notice.

3. A *Stay of Execution* against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgement is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to question 3 in the Acknowledgment of Service, that he intends to apply for a stay, execution will be stayed for fourteen (14) days after his Acknowledgement, but he must, within that time, *issue a Summons* for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by installments or otherwise.

### PARTICULARS

As to the planning, production and telecasting of the Defendant's commercials between the said dates full particulars these were set out in the Plaintiff's invoices to the Defendant numbered #1548, #1777, #2002, #2237, #2474, #2730, #2906, #3077, and #3273.

2. Pursuant to the invoices the Plaintiff claims the contractual interest rate of 1.5% per month amounting to the total interest of CI\$532.00 as of October 10, 2002 and increasing at a per diem rate of CI\$4.00.
3. Alternatively, the Plaintiff claims interest as prescribed by the Judicature Law (1995 Revision) and the Judgment Debts (Rates of Interest) Rules. The calculation of the yearly interest was prescribed at a rate of 4.5% from May 30, 2002 to the present. The total interest as of October 10, 2002 amounts to CI\$133.00 increasing at a per diem rate of CI\$1.00.

AND THE PLAINTIFF claims:

1. CI\$8,100.00 due under the Contract;

2. Contractual rate of interest at a rate of 1.5% per month amounting to the total interest of CI\$532.00 as of October 10, 2002 and increasing at a per diem rate of CI\$4.00;
