

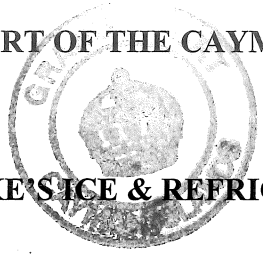

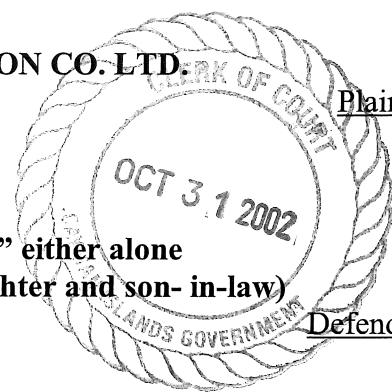

WRIT OF SUMMONS

THIS WRIT OF SUMMONS has been issued against you by the above named Plaintiff in respect of the claim set out on the next page.

Within 14 days after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495 GT, George Town, Grand Cayman, the accompanying Acknowledgement of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

NOTE- This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by order of the Court.

STATEMENT OF CLAIM


1. The Plaintiff is a company trading in the supply of refrigeration materials and services to customers for reward.
2. At all material times the Defendant traded as “Olson Construction”, a building and contracting business. Alternatively there was a partnership at will between the Defendant and her son-in-law, Harry Olson, and daughter, Beth Olson, (now dissolved by reason of their deaths) likewise trading as “Olson Construction”. In either event, the Defendant is liable for the price of goods sold and delivered by the Plaintiff to the Defendant.
3. Between June 1998 and February 2000 and at the request of the Defendant the Plaintiff sold and delivered and supplied refrigeration materials and services to the Defendant in the total sum of CI\$ 9,183.00 for which the Defendant has failed and refused to pay either in whole or in part.
4. Further, between August 2001 and November 2001 and at the request of the Defendant the Plaintiff sold and delivered and supplied ice to the Defendant in the total sum of CI\$1,557.00 for which the Defendant has failed and refused to pay either in whole or in part.
5. The Plaintiff further claims pre-judgment and post-judgment interest on the above amounts in accordance with the rates prescribed under the Judicature Law (1995 Revision) and the Judgment Debts (Rate of Interest) Rules. The total of said interest with respect to the refrigeration materials is presently CI\$ 1,576.68 and increasing at a

per diem rate of CI\$ 1.13. The total of said interest with respect to the delivery and supply of ice is presently CI\$ 63.65 and is increasing at a per diem rate CI\$ 0.19.

AND THE PLAINTIFF claims:

- (1) CI\$ 9,183.00 for delivery and supply of refrigeration materials and services;
- (2) CI\$ 1,557.00 for delivery and supply of ice;
- (3) Interest pursuant to Section 34 of the Judicature Act (1995 Revision) in the amount of CI\$ 1,576.68 and increasing at a per diem rate of CI\$1.13 with respect to the delivery and supply of refrigeration materials and services;
- (4) Interest pursuant to Section 34 of the Judicature Act (1995 Revision) in the amount of CI\$ 63.65 and increasing at a per diem rate of CI\$0.19 with respect to the delivery and supply of ice;
- (5) Costs to be taxed if not agreed.

This Writ of Summons and Statement of Claim was issued by Broadhurst DaCosta, Attorney for the Plaintiff, whose address for service is 40 Linwood Street, P.O. Box 2503, George Town, Grand Cayman, Cayman Islands, British West Indies,

INDORSEMENT

The amount claimed is CI\$ 10,740.00 as principal and CI\$ 1,640.33 as interest until the issue of the Writ of Summons for a total amount of CI\$ 12,380.33. The amount of the fixed costs is CI\$ 500.00 and the costs of issuing the Writ of Summons is CI\$150.00. plus the ad valorem fee of CI\$ 7.40. If, within the time for returning the Acknowledgement of Service, the Defendant pays the Plaintiff or its Attorneys-at-Law the total amount claimed in principal and interest, the fixed costs and the costs of issuing the Writ of Summons, further proceedings will be stayed. The money must be paid to the Plaintiff or to its Attorneys-at-Law.

STATEMENT REGARDING INTEREST WITH RESPECT TO DELIVERY AND SUPPLY OF REFRIGERATION MATERIALS AND SERVICES

- i. The date from which interest accrues for the refrigeration materials and services is the 1st day of March 2000;
- ii. The prescribed rate of interest from March 1, 2000 to March 31, 2000, was 7 percent. The total interest for that period is CI\$ 54.56;
- iii. The prescribed rate of interest from April 1, 2000 to May 31, 2001, was 8 percent. The total interest for that period is CI\$ 856.26;
- iv. The prescribed rate of interest from June 1, 2001 to November 30, 2001, was 6.25 percent. The total interest for that period is CI\$ 287.31;
- v. The prescribed rate of interest from December 1, 2001 to October 31, 2002 is 4.5 percent per year. The total interest for that period is CI\$ 378.55;
- vi. The total interest claimed as of the issuance of the Writ of Summons (October 31, 2002) is CI\$ 1,576.68;
- vii. The amount of interest accruing each day following the issue of the Writ is CI\$1.13.

STATEMENT REGARDING INTEREST WITH RESPECT TO DELIVERY AND SUPPLY OF ICE

- viii. The date from which interest accrues for the supply of ice is the 1st day of December 2001;

- ix. The prescribed rate of interest for the delivery and supply of ice from December 1, 2001 to October 31, 2002 is 4.5 percent per year. The total interest up until the issuance of the Writ of Summons (October 31st 2002) is CI\$ 63.65;
- x. The amount of interest accruing each day following the issue of the Writ is CI\$0.19.

**DIRECTIONS FOR ACKNOWLEDGEMENT OF SERVICE
OF WRIT OF SUMMONS**

1. The accompanying form of *Acknowledgement of Service* should be completed by an Attorney acting on behalf of the Defendant or by the Defendant if acting in person.

After completion it must be delivered or sent by post to the Law Courts, PO Box 495, George Town, Grand Cayman.

2. A Defendant who states in his Acknowledgement of Service that he intends to contest the proceedings *must also serve a defence* on the Attorney for the Plaintiff (or on the Plaintiff if acting in person).

If a Statement of Claim is endorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2). The defence must be served within fourteen (14) days after the time for acknowledging service of the Writ, unless in the meantime a summons for judgment is served on the Defendant.

If the Statement of Claim is not endorsed on the Writ, the defence need not be served until fourteen (14) days after a Statement of Claim has been served on the Defendant.

If the Defendant fails to serve his defence within the appropriate time, the Plaintiff may enter judgment against him without further notice.

3. A *Stay of Execution* against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgment is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to question 3 in the Acknowledgment of Service, that he intends to apply for a stay, execution will be stayed for fourteen (14) days after his Acknowledgement, but he must, within that time, *issue a Summons* for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by installments or otherwise.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgement of Service and return it to the Courts Office.
2. For the purpose of calculating the period of fourteen (14) days for acknowledging service, a Writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (*the name stated on the Writ of Summons*)".
4. Where the Defendant is a FIRM and an Attorney is not instructed, the form must be completed by a PARTNER by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual TRADING IN A NAME OTHER THAN HIS OWN, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a LIMITED COMPANY the form must be completed by an Attorney or by someone authorized to act on behalf of the Company, but the Company can take no further steps in the proceedings without an Attorney acting on its behalf.
7. Where the Defendant is a MINOR or a MENTAL HEALTH PATIENT, the form must be completed by an Attorney acting for a guardian *ad litem*.
8. A Defendant acting in person may obtain help in completing the form at the Courts Office.
