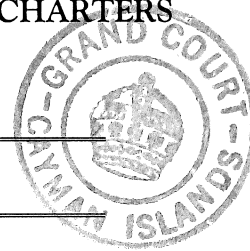

WRIT OF SUMMONS

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within 14 days after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, PO Box 495GT, Grand Cayman, the accompanying Acknowledgement of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

NOTE - This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by order of the Court.



STATEMENT OF CLAIM

1. The Plaintiff is a company, whose principal place of business is located at PO Box 1544GT, George Town, Grand Cayman.
2. The Defendant is an individual who resides in Grand Cayman, Cayman Islands and carries on business as Island Girl Charters with a mailing address of PO Box 107 BT, Grand Cayman, Cayman Islands.
3. On or about July 2000, the Defendant engaged the services of the Plaintiff to provide fuel. The Plaintiff company and the Defendant agreed, either expressly or impliedly, that the engagement was on the following terms:
 - (a) The Plaintiff would supply fuel to the Defendant;
 - (b) The Defendant would promptly pay invoices upon rendering;
 - (c) Interest would be charged at the rate of 1.5% per month on balances outstanding from 30 days after rendering of invoices as stated on the Invoice.
4. The Plaintiff did provide fuel and incurred expenses on the behalf of the Defendant.
5. The Defendant rendered invoices on the Defendant and Defendant made periodic payments until 27 May 2002 at which time the payments stopped.
6. Despite numerous Reminder Notices being sent to the Defendant no further payments have been made on this account.
7. The Plaintiff issued a formal demand on 16 October 2002 but no payments or proposals for payments have been received as of the date of this application.
8. The debt owed to the Plaintiff inclusive of principal and interest but not costs as at 12 November 2002 is CI\$3,176.48.
9. As a result of the above, the Plaintiff is entitled to the relief claimed.

AND THE PLAINTIFF CLAIMS:

1. Total amount owing in the amount of 3,176.48 in respect of the above-pleaded unpaid account;
2. Pre and Post judgment interest from 13 November 2002 in accordance with the contract as pleaded in 3(c).
3. Alternatively, Pre- and post-judgment interest in accordance with the Judicature Law (1995 Revision) and the Judgment Debt (Rates of Interest) Rules as amended from time to time;
4. Costs as taxed.

INDORSEMENT

The amount claimed in respect of the debt is CI\$3,176.48 as principal and service charge and costs to be assessed. If, within the time for returning the acknowledgement of service, the defendant pays the plaintiff or its attorneys-at-law the total amount claimed in principal, interest and the costs of issuing the writ of summons (CI\$150.00), further proceedings will be stayed. The money must be paid to the plaintiff or to its attorneys-at-law. If no payment is made, the Plaintiff elects to have costs taxed.

INDORSEMENT REGARDING INTEREST

(Order 6 (2)(e) of the Grand Court Rules)

- i. The contractual term upon which interest is 1½% per month as claimed in paragraph 3(c) of the Statement of Claim, above.
- ii. The prescribed rate of interest during the entire relevant is 1½% per month;
- iii. The date from which interest runs is the date of the respective accounts rendered.
- iv. The total interest claimed as at the date of the issue of the writ of summons is CI\$1,276.48.
- v. The amount of interest accruing each day following the issue of the writ of summons is CI\$1.25 per day

DIRECTIONS FOR ACKNOWLEDGMENT OF SERVICE
OF WRIT OF SUMMONS

1. The accompanying form of *Acknowledgment of Service* should be completed by an Attorney acting on behalf of each Defendant or by each Defendant if acting in person.

After completion it must be delivered or sent by post to the Law Courts, P.O. Box 495G, George Town, Grand Cayman.

2. A Defendant who states in his *Acknowledgment of Service* that he intends to contest the proceedings *must also serve a defence* on the Attorney for the Plaintiff (or on the Plaintiff if acting in person).

If a Statement of Claim is indorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2), the Defence must be served within 14 days after the time for acknowledging service of the Writ, unless in the meantime a summons for judgment is served on the Defendant.

If the Statement of Claim is not indorsed on the Writ, the Defence need not be served until 14 days after a Statement of Claim has been served on the Defendant.

If the Defendant fails to serve his defence within the appropriate time, the Plaintiff may enter judgment against him without further notice.

3. A *Stay of Execution* against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgment is entered. If A Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to Question 3 in the *Acknowledgment of Service*, that he intends to apply for a stay, execution will be stayed for 14 days after his *Acknowledgment*, but he must, within that time, *issue a Summons* for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by instalments or otherwise.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgement of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (*the name stated on the Writ of Summons*)".
4. Where the Defendant is a **FIRM** and an attorney is not instructed, the form must be completed by a **PARTNER** by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual **TRADING IN A NAME OTHER THAN HIS OWN**, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a **LIMITED COMPANY** the form must be completed by an Attorney or by someone authorised to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.
7. Where the Defendant is a **MINOR** or a **MENTAL PATIENT**, the form must be completed by an Attorney acting for a guardian *ad litem*.
8. A Defendant acting in person may obtain help in completing the form at the Courts Office.
