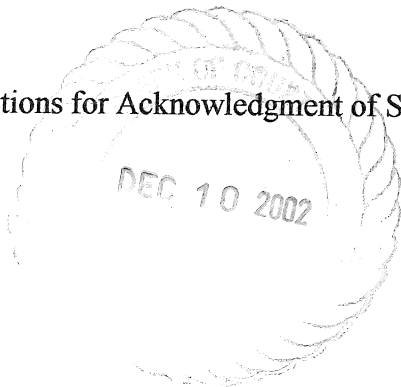
If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an interim to contest the proceedings, the Plaintiff may proceed with the action and judgement may be entered against you forthwith without further notice.

STATEMENT OF CLAIM

- (1) The Plaintiff at all material times lived at 14 Dias Lane, Rock Hole in a yard where the Defendant also rented a room.
- (2) The Plaintiff will say that in February of 2002 she discovered that there was an intimate relationship between the Defendant and her brother who was a married man.
- (3) On the 9th of March, 2002 the Plaintiff will say that she approached the Defendant at 14 Dias Lane and asked her to break off the relationship and a fuss developed between the parties during which the Defendant assaulted the Plaintiff by biting off the tip of her left index finger.
