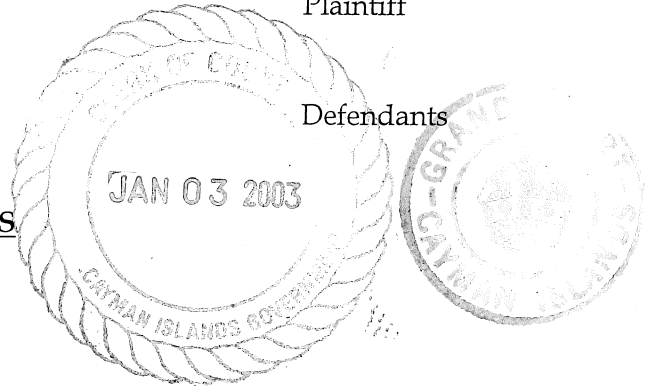

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within Fourteen [14] days after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495, George Town, Grand Cayman, the accompanying Acknowledgment of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

Issued this 3rd day of January 2003.

NOTE - This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by order of the Court.

STATEMENT OF CLAIM


1. The Plaintiff is a strata corporation created under the relevant laws of the Cayman Islands and by the Beach Bay Strata Corporation Bye-Laws and came into existence on the 23rd day of December, 1980 when Strata Plan No. 39 was registered in the Cayman Islands Land Registry.
2. The Defendants are the proprietors of Apartment No. 6 comprised in the said Strata Plan No. 39.
3. By Section 6(2) Strata Titles Registration Law 1996 the Corporation is empowered to establish a fund for, inter alia, administrative expenses, management and administration of the common parts, insurance, and repairs, and is empowered to levy contributions from the proprietors of the strata. By paragraph 34(c) of the Beach Bay Bye-Laws the Defendants are also obliged to pay such levy for the administration, management and upkeep of the strata property.
4. By a letter dated 4th December, 2002 the Plaintiff has demanded payment for the Defendant's contributions to the strata fund, the particulars of such payment being set out in a schedule annexed hereto exclusive of legal fees. Despite this request the Defendants have failed to pay the contributions to the fund that have become owing by them.
5. As at 31st December 2002, US\$5,240.22 in contributions remained outstanding.
6. The Defendant is therefore indebted to the Plaintiff in the sum of US\$5,240.22.

AND THE PLAINTIFF CLAIMS:

1. US\$5,240.22 being the amount outstanding.
2. The Plaintiff further claims interest pursuant to Section 34 of the Judicature Law on the sum of US\$5,240.22 from 31st December, 2002 at the rate of 4.5% amounting to US \$1.97 as at 3rd January 2002 and continuing until the date of Judgment or sooner payment at the rate of US \$0.65 per day.
3. Costs to be taxed if not agreed.

If within the time for returning the Acknowledgement of Service, the Defendants pay the total amount claimed of CI\$5,952.19 including all interest and costs, all further proceedings will be stayed. This money must be paid to the Plaintiff or its attorney.

DIRECTIONS FOR ACKNOWLEDGMENT OF SERVICE
OF WRIT OF SUMMONS

1. The accompanying form of *Acknowledgment of Service* should be completed by an Attorney acting on behalf of the Defendant or by the Defendant if acting in person.

After completion it must be delivered or sent by post to the Law Courts, P.O. Box 495GT, George Town, Grand Cayman.

2. A Defendant who states in his Acknowledgment of Service that he intends to contest the proceedings *must also serve a defence* on the Attorney for the Plaintiff (or on the Plaintiff if acting in person).

If a Statement of Claim is indorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2), the Defence must be served within 14 days after the time for acknowledging service of the Writ, unless in the meantime a summons for judgment is served on the Defendant.

If the Statement of Claim is not indorsed on the Writ, the Defence need not be served until 14 days after a Statement of Claim has been served on the Defendant

If the Defendant fails to serve his defence within the appropriate time, the Plaintiff may enter judgment against him without further notice.

3. A *Stay of Execution* against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgment is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to Question 3 in the Acknowledgment of Service, that he intends to apply for a stay, execution will be stayed for 14 days after his Acknowledgment, but he must, within that time, *issue a Summons* for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by installments or otherwise.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgment of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (*the name stated on the Writ of Summons*)".
4. Where the Defendant is a **FIRM** and an attorney is not instructed, the form must be completed by a **PARTNER** by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual **TRADING IN A NAME OTHER THAN HIS OWN**, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a **LIMITED COMPANY** the form must be completed by an Attorney or by someone authorised to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on his behalf.
7. Where the Defendant is a **MINOR** or a **MENTAL PATIENT**, the form must be completed by an Attorney acting for a guardian *ad litem*.
8. A Defendant acting in person may obtain help in completing the form at the Courts Office.
