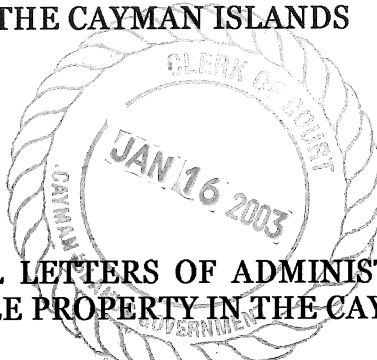



**BOND OF SURETY**


