If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

INDORSEMENT

The Plaintiff's claim against the Defendants is for CI\$4,300.92 being the price due to the Plaintiff by the Defendants for work and material supplied to the Defendants upon request. The Plaintiff's claim includes interest at the rate of 1½% per month to the date of filing of the writ. Thereafter, the Plaintiff claims interest pursuant to s.34 of the Judicature Law (2002 Revision) until satisfaction of the debt.

If, within the time for returning the Acknowledgement of Service, the Defendants pay the total amount claimed of CI\$4,300.92 (excluding fixed costs of CI\$250.00, filing fees of CI\$150.00 and accrued interest) further proceedings will be stayed. The money must be paid to the Plaintiff.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgment of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (the name stated on the Writ of Summons)".
4. Where the Defendant is a FIRM and an attorney is not instructed, the form must be completed by a PARTNER by name, with the addition in paragraph 1 of the description "partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual TRADING IN A NAME OTHER THAN HIS OWN, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a LIMITED COMPANY the form must be completed by an Attorney or by someone authorised to act on behalf of the company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.
7. Where the Defendant is a MINOR or a MENTAL PATIENT, the form must be completed by an Attorney acting for a *guardian ad litem*.
8. A Defendant acting in person may obtain help in completing the form at the Courts Office.
