

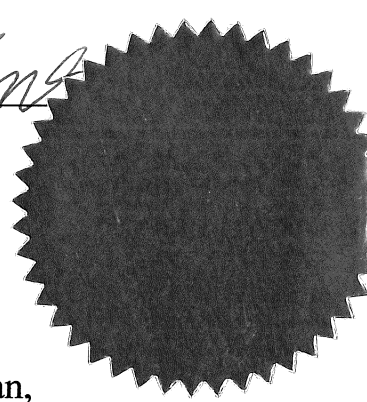





BOND OF SURETY

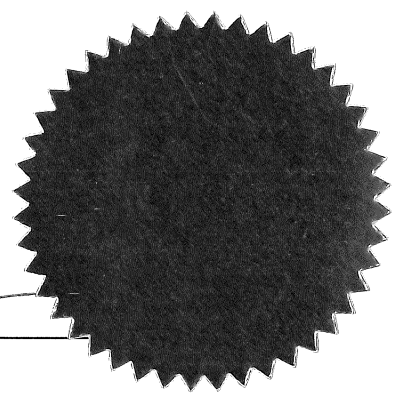
