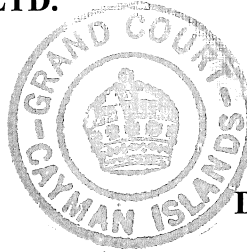

**WRIT OF SUMMONS**

**THIS WRIT OF SUMMONS** has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within 14 days after service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, PO Box 495 GT, George Town, Grand Cayman, the accompanying Acknowledgement of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgement may be entered against you forthwith without further notice.

**NOTE** - This Writ may not be served later than 4 calendar months beginning with the date of issue unless renewed by order of the Court.


STATEMENT OF CLAIM

1. By a Contract in writing referred to as a Memorandum of a Collateral Agreement dated 1<sup>st</sup> August 1996 ("the Contract"), in consideration of the Plaintiff advancing money by way of a loan to one Elorine Myrna Augustine, the Defendants covenanted with the Plaintiff to Guarantee the due payment of the loan in accordance with the terms of the Contract.
2. Pursuant to the Contract, the Plaintiff made advances to Elorine Myrna Augustine totalling CI\$50,000.00 together with interest, commission and banking charges which amounted to CI\$57,363.00.
3. At the date hereof, the said debt has increased, with interest, to the total sum of CI\$62,478.07.
4. Neither Elorine Myrna Augustine nor the Defendants have paid the sum of CI\$62,478.07 or any part of it despite demands made by the Plaintiff.
5. Further, the Plaintiff is entitled to and claims interest pursuant to Section 37 of the Judicature Law (1995 Revision) on the sum of CI\$62,478.07 at such rate and for such period of time as the Court shall think fit.

AND THE PLAINTIFF CLAIMS AGAINST THE DEFENDANTS:-

- (1) The sum of CI\$62,478.07 or the like sum as damages;
- (2) Interest pursuant to paragraph 5 above;
- (3) Costs.
