And I declare myself (and my successors) to be jointly and severally bound unto the Financial Secretary of the Islands in the sum of CI\$91,433.64.

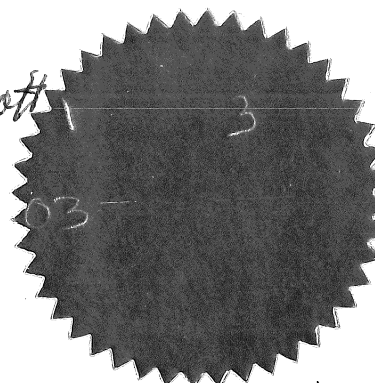

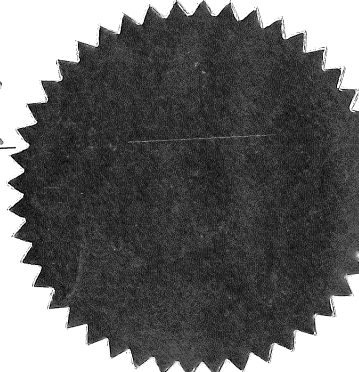
