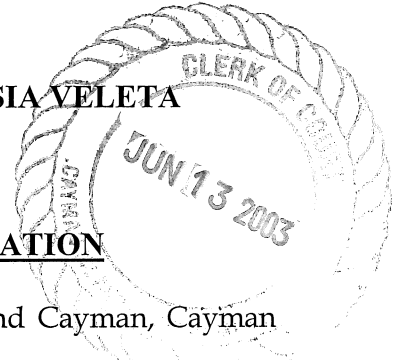


BOND

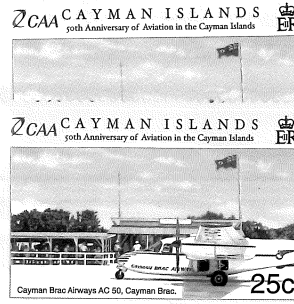


