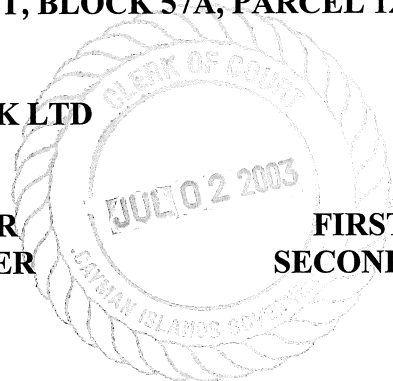

ORIGINATING SUMMONS

LET THE DEFENDANTS, Denison Ezzard Miller and Angela Jennifer Miller, within 14 days after service of this Summons on them, counting the day of service, return the accompanying acknowledgement of service to the Court office, P. O. Box 495 GT, George Town, Grand Cayman.

BY THIS SUMMONS which is issued on the application of the Plaintiff, Cayman National Bank Ltd, the Plaintiff seeks orders pursuant to the Registered Land Law (1995 Revision) as follows:-

1. The Plaintiff be entitled to sell the Property and that such sale be by either private treaty or public auction in good faith and having regard to the interests of the Defendants;
2. That the Plaintiff be entitled to vacant possession of the Property for the purposes of a sale of the Property;
3. After the sale of the said Property, should there be any shortfall in the amount due and owing to the Plaintiff that the Plaintiff be at liberty to enter Judgment against the Defendants for the said shortfall, together with interest and costs;
4. The costs of these proceedings be added to the principal and interest due from the Defendants and be deducted from the proceeds of sale.

The grounds upon which this relief is sought are set out in the affidavit of Milton Morrison dated 1st July 2003.
