THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within [14 days] after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court office, P.O. Box 495G, George Town, Grand Cayman, the accompanying Acknowledgement of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

Issued this 1st day of July 2003

NOTE - This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by order of the Court.

STATEMENT OF CLAIM

1. The Plaintiff is a company incorporated pursuant to the laws of the Cayman Islands and at all material times provided homeowners comprehensive insurance coverage to the Defendant. The Plaintiff's registered office is PO Box 10056 APO George Town, Grand Cayman.
2. The Defendant, The Good Life Ltd., is a company with a registered office at Ironshore Corporate Services Limited, PO Box 1234 GT, Grand Cayman, and was at all material times the policy holder of health insurance policies for its employees. The Defendant's mailing address is PO Box 260 GT.
3. In or about October 2000, the Plaintiff and the Defendant entered into an agreement whereby the Plaintiff would provide health insurance coverage for the Defendants employees, and the Defendant would pay all premiums:
4. The Plaintiff did provide such health insurance coverage to the Defendant's employees in accordance with the agreement until the insurance was cancelled by the Defendant effective 1 April 2003 due to the Defendant's failure to pay premiums as billed.
5. The Defendant failed to pay all premiums as due and as of the date of commencement of this proceeding the Defendant owes the sum of US\$7,654.49 plus interest and costs.
6. The Plaintiff claims interest at the rate as set by and in accordance with the Judicature Law (2002 Revision) from the date of the unpaid invoices (31 March 2003).
7. As a result of the default of the payments the entire sums set out in paragraphs 5, above are now due and owing plus interest and costs.

AND THE PLAINTIFF CLAIMS:

- a. Principal debt of US\$7,654.49;
- b. Pre judgment interest of US\$87.76 as of the date of commencement of this proceeding calculated in accordance with the Judicature Law (2002 Revision) from 31 March 2003 to commencement of proceedings (1 July 2003).
- c. Pre & Post Judgment interest, from 2nd July 2003, at the rate as set pursuant to the Judicature Law (2002 Revision) and Judgment Debt (Rates of Interest) Rules as amended from time to time;
- d. Costs pursuant to the Court Cost Rules 2001;
- e. Such further relief as this Honourable Court deems just.


INDORSEMENT

The amount claimed in respect of the debt is CI\$7,654.49 as principal and interest of CI\$87.76 until the date of the issuance of the Writ of Summons. Court filing fees of US\$182.93 and attorney fees are in addition to this. If, within the time for returning the acknowledgement of service, the defendants or one of them pays the plaintiff or its attorneys-at-law the total amount claimed in principal and interest, the fixed costs and the costs of issuing the Writ of Summons, further proceedings will be stayed. The money must be paid to the plaintiff or to its attorneys-at-law.

INTEREST INDORSEMENT

Pursuant to Order 6(2)(e)

1. Prescribed rate of interest during the entire period of the claim is 4.5% per year.
2. The date from which interest accrues is from 31 March 2003.
3. The total interest claimed as of the date of the issuance of the date of Writ of Summons is CI\$87.76.
4. The amount of interest accruing each day following the issuance of the Writ is CI\$0.9437.

DIRECTIONS FOR ACKNOWLEDGEMENT OF SERVICE OF WRIT OF SUMMONS

1. The accompanying form of Acknowledgement of Service should be completed by an Attorney acting on behalf of the Defendant or by the Defendant if acting in person.

After completion it must be delivered or sent by post to the Law Courts, P.O. Box 495 GT, George Town, Grand Cayman.

2. A Defendant who states in his Acknowledgement of Service that he intends to contest the proceedings must also serve a Defence on the Attorney for the Plaintiff (or on the Plaintiff if acting in person).

If a Statement of Claim is indorsed on the Writ (i.e. the words of "Statement of Claim" appear on the top of page 2), the Defence must be served within 14 days after the time for acknowledging service of the Writ, unless in the meantime a summons for judgment is served on the Defendant.

If the Statement of Claim is not indorsed on the Writ, the Defence need not be served until 14 days after a Statement of Claim has been served on the Defendant.

If the Defendant fails to serve his Defence within the appropriate time, the Plaintiff may enter judgment against him without further notice.

3. A Stay of Execution against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgment is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to Question 3 in the Acknowledgement of Service, that he intends to apply for a stay, execution will be stayed for 14 days after his Acknowledgement, but he must, within that time, issue a Summons for a Stay of Execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by instalments or otherwise.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgement of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (*the name stated on the Writ of Summons*)".
4. Where the Defendant is a FIRM and an attorney is not instructed, the form must be completed by a PARTNER by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual TRADING IN A NAME OTHER THAN HIS OWN, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a Limited Company the form must be completed by an Attorney or by someone authorised to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.
7. Where the Defendant is a MINOR or a MENTAL PATIENT, the form must be completed by an Attorney acting for a guardian *ad litem*.
8. A Defendant acting in person may obtain help in completing the form at the Courts Office.
