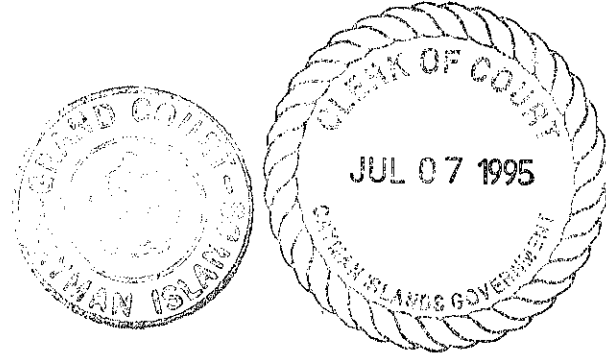

**Within** fourteen (14) days after service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O.Box 495G, George Town, Grand Cayman, the accompanying Acknowledgement of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgement may be entered against you forthwith without further notice.

**NOTE** - This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by order of the Court.

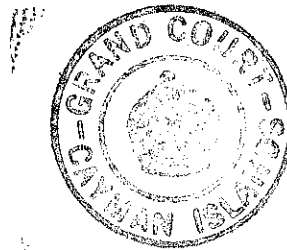
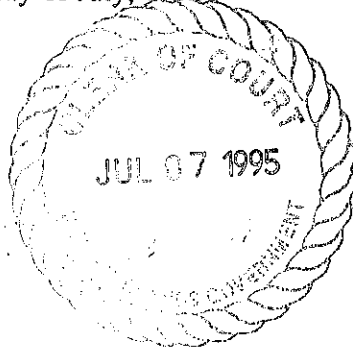
**STATEMENT OF CLAIM**

1. The plaintiff is a local Company with a licence to sell ready mixed concrete.
2. The defendant lives in West Bay.
3. On the 27th March, 1995 the plaintiff supplied the defendant at Town Hall Cressent with 32 yards of ready mixed concrete at a price of \$104.50 per yard at a total costs of \$3,344.00
4. The defendant promised to pay for the said concrete but, despite several demands, he has failed to pay.

WHEREFORE, the plaintiff Claims:-

1. the amount due =\$3,440.00
2. Interest at the rate of 83/8% from the date of  
Judgement until payment
4. Costs to be taxed if not agreed.

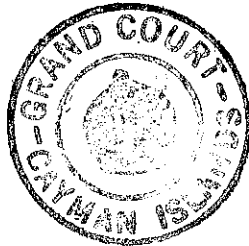
