THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within 14 days after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, PO Box 495GT, Grand Cayman, the accompanying Acknowledgement of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

Issued this 27 August 2003.

NOTE - This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by order of the Court.


STATEMENT OF CLAIM

1. The Plaintiff is and was at all materials times a retail store carrying on the business of selling construction and home improvement products in the Cayman Islands. Its registered office P.O. Box 244GT, Grand Cayman, Cayman Islands. Its address for service in this proceedings is in care of its attorneys, Hunter & Hunter.
2. The Defendant is an individual residing in the Cayman Islands and is the proprietor of a construction business trading as "Capo Construction" with a mailing address of P.O. Box 1689 GT Grand Cayman, Cayman Islands.
3. The Plaintiff and the Defendant entered into a credit agreement dated 9th April 2002 whereby the Plaintiff agreed to supply goods to the Defendant on credit as may be granted from time to time. The express or implied terms of the agreement included as follows:
 - a. The Plaintiff at its discretion would extend credit to the Defendant for the supply of various goods sold by the Plaintiff;
 - b. The Defendant agreed to pay for goods received in accordance with the terms set out on each invoice which was 10 days of the rendering of the account for the goods received;
 - c. The Defendant would pay a service charge or interest of 1.5 per cent per month (18 % per year) on all sums unpaid following a period of 10 days from the rendering of an account.
 - d. If the Plaintiff referred the collection of unpaid balances to an attorney, the Defendant would pay to the extent permitted by law, all reasonable attorney's fees and all costs in connection with such referral.
4. The Plaintiff did extend credit to the Defendant from time to time and rendered invoices for the supply of goods purchased by the Defendant.
5. Notwithstanding the extension of credit, the Defendant was unable or unwilling to make payments on the accounts rendered in breach of the agreement pleaded herein.
6. The Plaintiff made demand for payment on the Defendant including a demand from its attorneys dated 5 May 2003. Notwithstanding the demand, the Defendant made one instalment payment of CI\$1,000.00 but has been unable or unwilling to pay anything further.
7. The total principal and interest amount due by the Defendants to the Plaintiff as at 27th August 2003 is:
 - a. Principal Debt CI\$ 9,885.01
 - b. Service Charge CI\$ 1,458.24
 - CI\$11,343.25

8. The Plaintiff further claims legal fees and expenses in relation to the collection of this debt. Interest in accordance with the pleaded agreement continues to accrue from 28 August 2003 and is claimed in addition to the sums set out in paragraph 7 above.
9. As a result of the above, the Defendant is liable to the Plaintiff in the sums as set out in this Statement of Claim.

AND THE PLAINTIFF CLAIMS

- a) 9,885.01 principal debt;
- b) Pre-Judgment interest, calculated to 27 August 2003 of CI\$1,458.24 at the rate of 1½ % per month in accordance with the agreement pleaded in the Statement of Claim at paragraph 3 c, above;
- c) Pre and post-judgment interest from 28 August 2003 at the rate of 1½ % per month in accordance with the agreement pleaded in the Statement of Claim at paragraph 3 c, above;
- d) Alternatively, pre and post judgment interest in accordance with the Judicature Law (2002 Revision) and the Judgment Debts (Rates of Interest) Rules as amended from time to time.
- e) Legal fees and expenses on a contractual basis, in accordance with 4(d) and 8;
- f) Alternatively, costs on a standard or indemnity basis in accordance with the Grand Court Rules.
- g) Such further and other relief as this Court may deem just;

INDORSEMENT

The principal amount claimed in respect of the debt is CI\$9,885.01 and interest as of the date of commencement of the proceeding is CI\$1,458.24 and costs on an indemnity basis. The amount of the filing fees to commence the proceeding is CI\$150.00. If, within the time for returning the acknowledgement of service, the defendant pays the plaintiff or its attorneys-at-law the total amount claimed in principal, interest, and the costs of issuing the writ of summons, further proceedings will be stayed. The money must be paid to the plaintiff or to its attorneys-at-law.

INDORSEMENT REGARDING INTEREST

(Order 6 (2) (e) of the Grand Court Rules)

- i. The contractual term upon which interest is 1.5 % per month as claimed in paragraph 3(c) of the Statement of Claim, above.
- ii. The prescribed rate of interest during the entire relevant period is 1.5 % per month;
- iii. The date from which interest runs is the date of the respective accounts rendered.
- iv. The total interest claimed as at the date of the issue of the writ of summons is CI\$1,458.24.
- v. The amount of interest accruing each day following the issue of the writ of summons is CI\$4.87 per day;

DIRECTIONS FOR ACKNOWLEDGMENT OF SERVICE
OF WRIT OF SUMMONS

1. The accompanying form of *Acknowledgment of Service* should be completed by an Attorney acting on behalf of each Defendant or by each Defendant if acting in person.

After completion it must be delivered or sent by post to the Law Courts, P.O. Box 495G, George Town, Grand Cayman.

2. A Defendant who states in his *Acknowledgment of Service* that he intends to contest the proceedings *must also serve a defence* on the Attorney for the Plaintiff (or on the Plaintiff if acting in person).

If a Statement of Claim is indorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2), the Defence must be served within 14 days after the time for acknowledging service of the Writ, unless in the meantime a summons for judgment is served on the Defendant.

If the Statement of Claim is not indorsed on the Writ, the Defence need not be served until 14 days after a Statement of Claim has been served on the Defendant.

If the Defendant fails to serve his defence within the appropriate time, the Plaintiff may enter judgment against him without further notice.

3. A *Stay of Execution* against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgment is entered. If A Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to Question 3 in the *Acknowledgment of Service*, that he intends to apply for a stay, execution will be stayed for 14 days after his *Acknowledgment*, but he must, within that time, *issue a Summons* for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by instalments or otherwise.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgement of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (*the name stated on the Writ of Summons*)".
4. Where the Defendant is a **FIRM** and an attorney is not instructed, the form must be completed by a **PARTNER** by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual **TRADING IN A NAME OTHER THAN HIS OWN**, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a **LIMITED COMPANY** the form must be completed by an Attorney or by someone authorised to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.
7. Where the Defendant is a **MINOR** or a **MENTAL PATIENT**, the form must be completed by an Attorney acting for a guardian *ad litem*.
8. A Defendant acting in person may obtain help in completing the form at the Courts Office.
