



LET ALL PARTIES CONCERNED attend before the Judge in Chambers at the Law
Courts, George Town, Grand Cayman, on the 8 day of ~~SEPT~~ 2003 at 9:30
o'clock on the hearing of an application by the Third Defendant, Cayman National Bank
Ltd, of Cayman National Building, PO Box 1097 GT, Grand Cayman, Cayman Islands
BWI ("the Applicant") for directions pursuant to Section 4 of the Confidential
Relationships (Preservation) Law (1995 Revision) ("the Law").

The Applicant is required by an Order of Mrs Justice Levers dated 11 August 2003 in
cause number 357 of 2003 ("the Order for disclosure") to give in evidence confidential
information belonging to the Second Defendant, Olympia Funding Ltd, by disclosing
information and confirming the disclosure by sworn affidavit and by disclosing
documents and permitting the Plaintiff's attorneys to take copies of documents. The
Applicant seeks the following directions, in the form of the draft Order attached hereto,
pursuant to Section 4 of the Law:

1. The Applicant is directed pursuant to Section 4 of the Law:
 - 1.1 to comply, within 7 days of the date of this Order, with sub-paragraph 3(1) of the Order for disclosure by disclosing the information specified in that paragraph and by confirming that disclosure by sworn affidavit to be served on Quin & Hampson, the attorneys for Molly Lori Young.
 - 1.2 to comply, within 7 days of the date of this Order, with sub-paragraph 3(2) of the Order for disclosure, by disclosing the information and documentation specified in that sub paragraph by sending to Quin & Hampson such of those documents and information specified in sub-paragraph 3(2) of the Order for disclosure which are in the possession of the Applicant and which the Applicant has so far been able to locate and ascertain.
 - 1.3 the Applicant shall continue to search for any further documents and information specified in sub-paragraph 3(2) of the Order for disclosure and shall disclose any further documents and information so located or ascertained to Quin & Hampson forthwith on such discovery or location.

- 1.4 at the end of 14 days from the date of this Order, if there remain documents or information specified in sub-paragraph 3(2) of the Order for disclosure which the Applicant has not been able to locate or ascertain, the Applicant shall not be required to continue to search for such information and documentation or to disclose it to Quin & Hampson and the Applicant will not be required to take any further steps to comply with the Order for disclosure, without further order of the Court or agreement between the Applicant and Molly Lori Young.
- 2 Nothing in this Order shall require the Applicant to disclose any information or documentation specified in the Order for disclosure which the Applicant has been unable to locate or ascertain or which the Applicant is not subsequently able to locate or ascertain pursuant to the search mentioned in paragraph 1.3 of this Order and the Order for disclosure is varied accordingly.
- 3 The costs of and occasioned by the Applicant's Originating Summons be paid by Molly Lori Young in any event.
