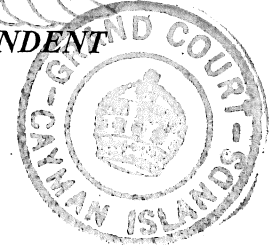

1. That Custody of the above named minors, Argueta and Sevilla, be made to the Applicants.


