



## **STATEMENT OF CLAIM**

1. The Plaintiff rented under written agreement a single bedroom apartment to the Defendant located at the Plaintiff's residence, which is located at #43 Lake Forest Way, Ryan Road, Crewe Road, Grand Cayman, Cayman Islands at a monthly charge of CI\$650.00 from January 2002 through June 2002.
2. The Defendant consistently failed to pay the rents due to the Plaintiff and as at June 2002 owed the Plaintiff CI\$3,150.00 in unpaid rents.
3. The Plaintiff has made numerous demands for payment to the Defendant. However, despite repeated promises by the Defendant to settle the debt owed, the Defendant has either neglected / failed or refused to pay the money owed to the Plaintiff or any part of it.

### **AND THE PLAINTIFF CLAIMS AGAINST THE DEFENDANT:-**

1. Payment of the said sum of CI\$3,150.00.
2. Interest on the said sum as aforesaid at the rate of 4 1/2% per annum from the date the account became delinquent on June 2002 until the commencement of these proceedings in the sum of CI\$189.00 and continuing at the daily rate of \$0.39
3. Fixed costs in the sum of CI\$100.00 together with the fees payable for issuing this Writ in the sum of CI\$150.00.
4. Any further or other relief as this Honourable Court may deem just.

[If within the time for returning the Acknowledgement of Service, the Defendant pays the total amount claimed of Three Thousand Dollars Five Hundred Eighty Nine Dollars and No Cents Cayman Islands Dollars (CI\$3,589.00), then further proceedings will be stayed. The money must be paid to the Plaintiff.]
