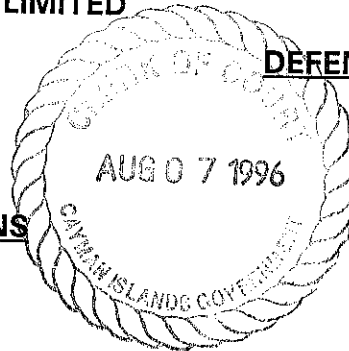

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

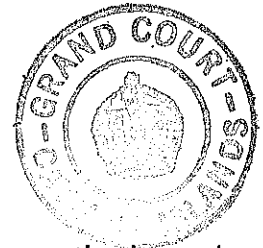
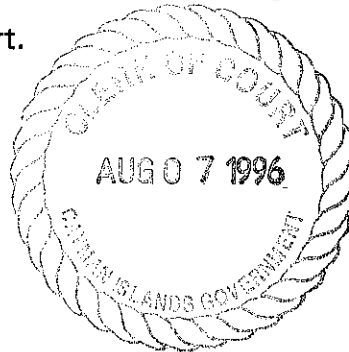
Within 14 days after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P. O. Box 495G, George Town, Grand Cayman, the accompanying Acknowledgment of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

NOTE - This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by order of the Court.

INDORSEMENT



The Plaintiff's claim is for:-

- (1) A declaration that the Plaintiff is the sole beneficial owner of the entire issued share capital of the ("the Share Capital") of the First Defendant.
- (2) In the alternative to (1), a Declaration as to the extent of the Plaintiff's beneficial ownership of the Share Capital;
- (3) An Order vesting in the Plaintiff the Share Capital (alternatively, such portion of the Share Capital of which the Plaintiff is the beneficial owner);

- (4) All necessary accounts, enquiries and directions;

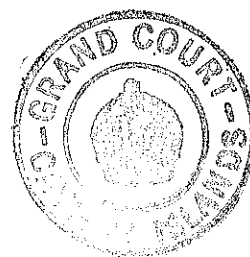
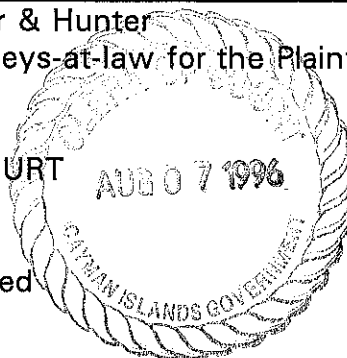
