
LET THE DEFENDANTS of the address set out above attend before the Judge in Chambers, at the Law Courts, George Town, Grand Cayman on the 22nd day of March 2004 at 9^o clock in the hearing of an application by the Plaintiff of P.O. Box 914 GT, Grand Cayman, Cayman Islands for the following orders:

1. A declaration that the Defendants are in default of payment of the principal sum payable under a Charge made between the Defendants and the Plaintiff, Fidelity Bank (Cayman) Limited ("the Charges"), by virtue of which the property in the Registration Section George Town East, Block 20E, Parcel 310H63 was charged by the Defendants by way of legal charge in favour of the Plaintiff to secure the principal sum of CI\$77,950.00 and interest at the rate specified in the schedules thereto.
2. Delivery by the Defendants to the Plaintiff of possession of the Property.

3. An order that the Charge be enforced by the sale by private treaty of the Property (as well as by Public Auction).
4. An Order determining the terms and conditions of sale by private treaty, if any.
5. Such further or other relief as the Court thinks fit.
6. Costs.

AND LET THE DEFENDANTS within 14 Days after service of this summons on them counting the day of service, return the accompanying Acknowledgement of Service to the Courts Office.
