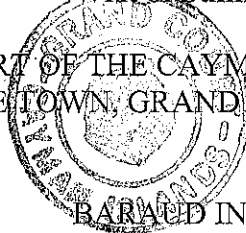
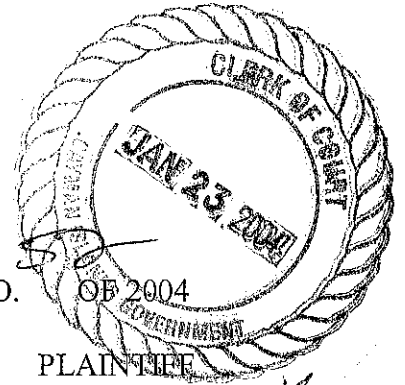

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within 14 days after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495G, George Town, Grand Cayman, the accompanying Acknowledgment of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

Issued this 23 day of January 2004

NOTE - This Writ may not be served later than 4 calendar months beginning with the date of issue unless renewed by order of the Court.

STATEMENT OF CLAIM

1. By a written agreement contained in and evidenced by a Letter dated 13 May 2003 (the "agreement") made between the Plaintiff and Defendant it was agreed that the Plaintiff would provide support staff, namely Rebecca McMillan, to the Defendant to assist the Defendant at its place of employment and that the Defendant would pay the Plaintiff for the services provided at the charge out rate of CI\$22.00 per hour for the use thereof.
2. The Agreement to which the Plaintiff will refer as may be necessary for its full terms, meaning and effect, provided, *inter alia*, as follows:

"Thank you for giving us the opportunity to provide you with temporary support through Rebecca Macmillan. Our charge out rate will be CI\$22.00 per hour and cheques should be made payable to Baraud International. Please note that we do ask that our temporary support staff work a minimum of 7.5 hours per day unless otherwise agreed.

At the end of each week the employee will present a time sheet to the immediate supervisor for verification and you will be billed accordingly and we do expect payment immediately. Payment of overtime and public holidays is in accordance with the Labour Law. Please let us know if, for any reason, your department is not satisfied with the individual assigned and we will do everything possible to find you a suitable replacement."

3. Pursuant to the agreement Rebecca Mcmillan worked for the Defendant on the following dates: 5 to 18 May, 19 May to 1 June and 2 June to 15 June 2003. The fees for the services provided were CI\$1,630.75, CI\$1,056.00 and CI\$374.00 respectively. The time sheets for each period worked was verified by the immediate supervisor and signed in accordance with the terms of the agreement. The total sum owed to the Plaintiff is CI\$3,060.75.
4. In breach of the agreement the Defendant has failed and refuses to pay the Plaintiff the sum owed namely CI\$3,060.75.

And the plaintiff claims:

- (1) Damages of CI\$3,060.75.
- (2) Interest on (4) above pursuant to The Judicature Law (1995 Revision), the plaintiff is entitled to and claims interest on such sums as are found to be due at the statutory rate and for such period as the Court shall think fit.
