

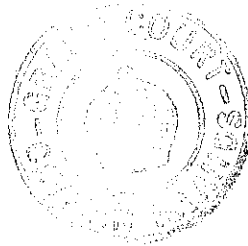

**THIS WRIT OF SUMMONS** has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within 14 days after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495G, George Town, Grand Cayman, the accompanying Acknowledgment of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiffs may proceed with the action and judgment may be entered against you forthwith without further notice.

**NOTE** - This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by order of the Court.

AND THE PLAINTIFF CLAIMS:-

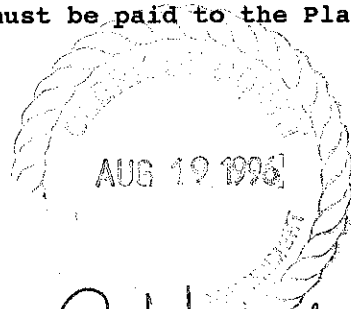
1. the principal sum of US\$2,716.65
2. Pre-judgment interest pursuant to the Judicature Law (1995 Revision) and the Judgment Debs (Rates of Interest) Rules 1995 and 1996 as pleaded in paragraph 5 hereof in the sum of US\$168.85.
3. Post-judgment interest pursuant to the Judgement Debs (Rates of Interest) Rules 1996 from the date of judgment
4. Such further or other relief as this Honourable Court deems fit
5. Costs.

If, within the time for returning the Acknowledgment of Service the Defendant pays the total amount claimed of US\$4,385.50 (including interest and costs) namely:-

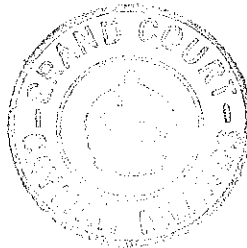
