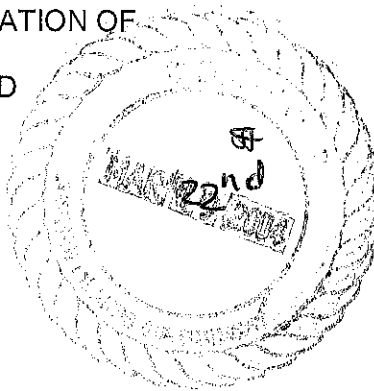

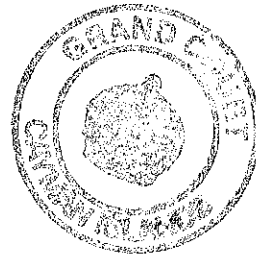

**THIS WRIT OF SUMMONS** has been issued against you by the above-named Plaintiff in respect of the claim set out hereafter.

Within 14 days after service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Courts Office, P. O. Box 495GT, George Town, Grand Cayman, the accompanying Acknowledgment of Service form stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgment within the time stated or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

## STATEMENT OF CLAIM

1. The Plaintiff is a banker carrying on business at its branch at 25 Main Street, P.O. Box 1321GT, George Town, Grand Cayman, Cayman Islands, and elsewhere.
2. The Defendants are and were at all material times customers of the Plaintiff at the said branch.
3. On 9 April 1997 the Plaintiff loaned the Defendants the sum of CI\$133,000.00 repayable over twenty years at the rate of CI\$1,385.00 per month. Pursuant to the loan interest was payable on the sum lent at the rate of 3% per annum over the prime interest rate, effectively 7% per annum at the present time.
4. The loan was granted to assist with the construction of a house and to repay debts owed to Barclays Bank Plc. In consideration of the Plaintiff's loan to the Defendants, a charge in favour of the Plaintiff was granted by the Defendants over registration section Cayman Brac Central, Block 101C, Parcel 15 ("the Property"). The Defendants failed to repay the loan in accordance with its terms.
5. The Plaintiff made written demand for repayment of the loan by letter dated 15 February 2000, but the Defendants failed to repay the sum outstanding.
6. Enforcement proceedings were commenced in relation to the charge over the Property and between April 2000 and July 2001 notices pursuant to Section 64(2) and 72 (1) of the Registered Land Law (1995 Revision) were served on the Defendants, but the Defendants have failed to repay the sum outstanding.
7. The Plaintiff then obtained valuations of the Property and it was offered for sale by public auction on 6 February 2004. The public auction was unsuccessful with


only one sealed bid of CI\$45,000.00 having been received. A separate application is being made to court for leave to sell the property privately.

8. As at 25 February 2004 the total amount outstanding was CI\$205,756.03 against the total amount advanced of CI\$133,000.00. Interest continues to accrue on the loan.

**AND THE PLAINTIFF CLAIMS:**

- (a) The sum of CI\$205,756.03;
- (b) Interest pursuant to the loan at the rate of 7% per annum from 26 February 2004 accruing at the rate of CI\$39.46 per diem until payment or judgment, alternatively, judicial interest;
- (c) Payment of ad valorem Court fees of CI\$1,065.00;
- (d) Further and other relief;
- (e) Costs, to be taxed if not agreed.

**Notes on address for Service**

Attorney: where the Defendant is represented by an attorney, state the attorney's place of business in the Cayman Islands. A Defendant may not act by a foreign attorney.

Defendant in person: where the Defendant is acting in person, he must give his post office box number and the physical address of his residence or, if he does not reside in the Cayman Islands, he must give an address in Grand Cayman where communications for him should be sent. In the case of a limited company, "residence" means its registered or principal office.

**DIRECTIONS FOR ACKNOWLEDGMENT OF SERVICE OF  
WRIT OF SUMMONS**

1. The accompanying form of *Acknowledgment of Service* should be completed by an Attorney acting on behalf of the Defendant or by the Defendant if acting in person.
2. After completion it must be delivered or sent by post to the Courts Office, P.O. Box 495G, George Town, Grand Cayman.
3. A Defendant who states in his Acknowledgment of Service that he intends to contest the proceedings *must also serve a defence* on the Attorney for the Plaintiff (or on the Plaintiff if acting in person).
4. If a Statement of Claim is indorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2), the Defence must be served within 14 days after the time for acknowledging service of the Writ, unless in the meantime a summons for judgment is served on the Defendant.
5. If the Statement of Claim is not indorsed on the Writ, the Defence need not be served until 14 days after a Statement of Claim has been served on the Defendant.
6. If the Defendant fails to serve his defence within the appropriate time, the Plaintiff may enter judgment against him without further notice.
7. A *Stay of Execution* against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgment is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to Question 3 in the Acknowledgment of Service, that he intends to apply for a stay, execution will be stayed for 14 days after his Acknowledgment, but he must, within that time, *issue a Summons* for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by instalments or otherwise.

## NOTES FOR GUIDANCE

1. Each Defendant (if there are more than one) is required to complete an Acknowledgment of Service and return it to the Court's office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (*the name stated on the Writ of Summons*)".
4. Where the Defendant is a FIRM and an attorney is not instructed, the form must be completed by a PARTNER by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual TRADING IN A NAME OTHER THAN HIS OWN, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a LIMITED COMPANY the form must be completed by an Attorney or by someone authorised to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.
7. Where the Defendant is a MINOR or a MENTAL PATIENT, the form must be completed by an Attorney acting for a guardian *ad litem*.
8. A Defendant acting in person may obtain help in completing the form at the Court's office.
