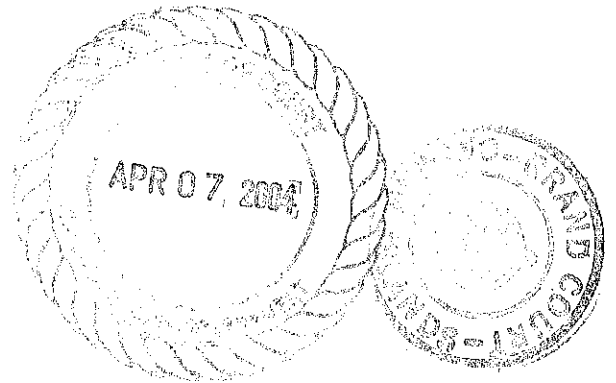

If you fail to satisfy the claim or return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings the Plaintiff may proceed with the action and judgement may be entered against you forthwith without further notice.



INDORSEMENT TO WRIT

AND THE PLAINTIFFS CLAIM:

1. Rescission of an agreement made on or about the 28th day of March 2003 between the Plaintiffs and the Defendant in respect of the purchase of a 53ft. Hatteras Sport Fishing boat "Last Fling" for the purpose of operating a charter fishing business jointly with the Plaintiffs;
2. An Order that the said boat be delivered to the Plaintiffs and that it be registered in the names of the Plaintiffs; alternatively
3. Damages for fraudulent misrepresentation in the sum of CI\$75,000.00; and in any event
4. Damages in respect of the sums advanced in the amount of CI\$21,330.00;
