
LET THE DEFENDANT of the addresses set out above attend before the Judge in Chambers, at the Law Courts, George Town, Grand Cayman on the 9th day of June 2004 at 9:30 am in the hearing of an application by the Plaintiff of P.O. Box 914 GT, Grand Cayman, Cayman Islands for the following orders:

1. A declaration that the Defendant is in default of payment of the principal sum payable to the Plaintiff and secured by the charge described below:
 - Registered on 11th October 1994 and identified as instrument #6182/94;
between the Defendant and the Plaintiff, Fidelity Bank (Cayman) Ltd., (formerly British American Bank Ltd.) (the "Charge") by virtue of which the property in the **Registration Section Savannah Block 28C, Parcel 187** (the "Property") was charged by the Defendant in favour of the Plaintiff to secure the principal sum of US\$107,317.00 and interest at the rate specified in the schedules thereto.
2. Delivery by the Defendant to the Plaintiff of possession of the Property.
3. An order that the Charge be enforced by the sale by private treaty of the Property (as well as by public auction).
4. An Order determining the terms and conditions of sale by private treaty, if any.

5. Such further or other relief as the Court thinks fit.
6. Costs on an indemnity basis as set out in the pleaded Charges.

AND LET THE DEFENDANT within 14 Days after service (within 28 days of service if served out of the jurisdiction) of this summons on her counting the day of service, return the accompanying Acknowledgement of Service to the Courts Office.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgment of Service and return it to the Court's Office.
2. If you wish to defend claims made in the originating summons, or intend to attend the proceedings and to participate in them so far as necessary (although not necessarily in an adversarial manner) you should tick the "Yes" box in paragraph 2 of the acknowledgment of service.
3. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
4. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (*the name stated on the Originating Summons*)".
5. Where the Defendant is a **FIRM** and an attorney is not instructed, the form must be completed by a **PARTNER** by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
6. Where the Defendant is sued as an individual **TRADING IN A NAME OTHER THAN HIS OWN**, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
7. Where the Defendant is a **LIMITED COMPANY** the form must be completed by an Attorney or by someone authorised to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.
8. Where the Defendant is a **MINOR** or a **MENTAL PATIENT**, the form must be completed by an Attorney acting for a guardian *ad litem*.
9. A Defendant acting in person may obtain help in completing the form at the Courts Office.
