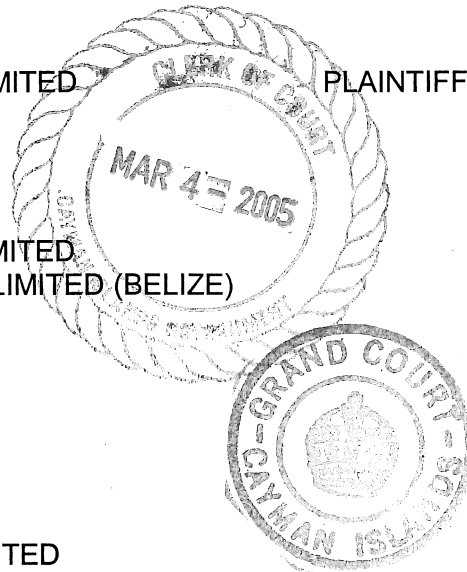

LET THE DEFENDANTS, within 28 days after service of this Summons on them, counting the day of service, return the accompanying Acknowledgment of Service to the Courts Office, P.O. Box 495G, George Town, Grand Cayman. Cayman Islands

BY THIS SUMMONS, which is issued on the application of KESTREL STOCK TRADING CO. LIMITED of 1 Costakis Pantelides Avenue, CY-1010 Nicosia, Cyprus, the Plaintiff seeks the following relief against the Defendants, namely an Order that:

1. The following trusts ("the Trusts") may be carried into execution by this Honourable Court –

- 1.1 a trust called "The HPH Settlement" which was made by deed under Cyprus law on 4th December, 2002 between a company incorporated in the Cayman Islands called HPH Cayman Limited (as settlor), a company incorporated in Cyprus called Daventree Trustees Limited

(as trustee), and an individual resident in the Republic of Slovakia called Juraj Siroky (as protector); of which the class of beneficiaries is comprised of the registered shareholders of a company incorporated in the Czech Republic called Harvardsky Prumyslový Holdings a.s.; and

1.2 a trust called "The HPH Distribution Settlement No. 2" which was made by deed under Cyprus law on 6th February, 2003 between the same parties in the same capacities, on the same terms, and with the same beneficiaries, as the HPH Settlement.

2. If and insofar as may be necessary the Trusts and each of them be taken into administration by the court.
3. An inquiry be made of what particulars the property in the jurisdiction now subject to the Trusts consists.
4. All necessary and proper consequential directions, accounts and enquiries be made.
5. That provision may be made for the costs of this Application.
6. Further or other relief.

If the Defendants do not acknowledge service, such judgment may be given or Order made against or in relation to the Defendants as the Court may think just and expedient.
