

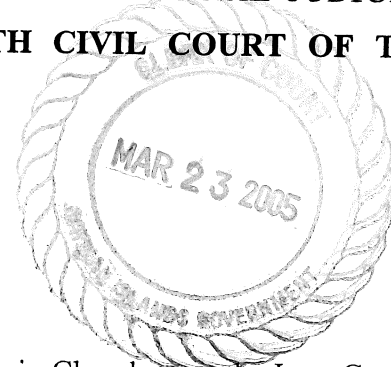

ORIGINATING SUMMONS


LET ALL PARTIES concerned attend before the Judge in Chambers at the Law Courts, George Town, Grand Cayman on the 1st day of April 2005 at 9³⁰ o'clock in the forenoon upon an application by the Attorney General for the following orders that;

1. A legal representative or attorney of Prodipe Inc. located at O.L.Panton & Company, Pansons Buildings, Crewe Road, P.O. Box 875-786GT, George Town, Grand Cayman be summoned to attend upon the Courts to be examined by the Clerk of the Courts concerning the original document denoted as "GENERAL RELEASE" dated April 12, 1996.
2. The legal representative or attorney of Prodipe Inc. produces the original document/deed of release noted as "GENERAL RELEASE" dated April 12, 1996
3. The Clerk of the Courts shall examine and record the answers from the legal representative or attorney as to this said document as regards the attorney's or legal representative's acknowledgement/recognition of the document, its text and authenticity as belonging to Prodipe Inc in accordance with the schedule of questions attached hereto.

4. The Clerk of the Courts be directed to return to the Superior Court of Justice of the Federal District of Mexico, Fifty Seventh Civil Court, Reference File # 565/96 with address at: Av. Ninod Heroes #132, Torre Sur, Fourth Floor, Supreme Court of Justice of the Federal District the following:
 - a) The Letters Rogatory
 - b) The original document named "GENERAL RELEASE" dated April 12, 1996 and/or copy thereof
 - c) The certified document evidencing the deposition/statement of the attorney or legal representative of Prodipe Inc.

5. Such other orders and directions as the court deems fit.
