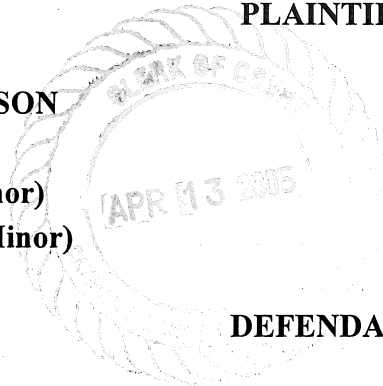
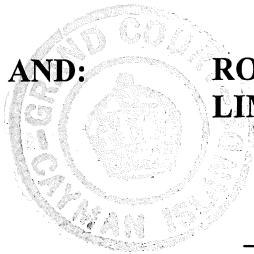

ORIGINATING SUMMONS

LET ALL PARTIES attend before the Judge in Chambers at the Grand Court, George Town, Grand Cayman on the day of 2005 at a.m./p.m. for the hearing of an application by the Plaintiff for the following:

1. A Declaration that the restatement by the Defendant acting as Trustee of a certain settlement made on 24th December 1996 by the Defendant known as the Nomad Trust into a certain settlement made on 31st December 2001 by the Plaintiff known as the Ardher Trust and all subsequent Deeds of Amendment to the Ardher Trust is invalid and void.
2. An Order that the restatement by the Defendant acting as Trustee of the Nomad Trust into the Ardher Trust dated 31st December, 2001 and all subsequent Deeds of Amendment to the Ardher Trust is hereby set aside.
3. A Declaration that the Second Deed of Amendment in relation to a certain settlement made on 24th December 1996 by the Defendant known as the Makar

Trust, dated 31st December, 2001 appointing the Makar Novus Trust as a Capital Beneficiary and an Income Beneficiary is invalid and void.

4. An Order that the Second Deed of Amendment for the Makar Trust dated 31st December 2001 appointing the Makar Novus Trust as a Capital Beneficiary and an Income Beneficiary be set aside.
5. A Declaration that the Deed of Appointment dated 31st December, 2001 appointing all rights, title and interest in AP Inc., CP Ltd. and Mercer Loft LLC absolutely to the Makar Novus Trust is invalid and void.
6. An Order that the Deed of Appointment pursuant to the Makar Trust dated 31st December, 2001 appointing all rights, title and interest in AP Inc., CP Ltd. and Mercer Loft LLC absolutely to the Makar Novus Trust be set aside.
7. A Declaration that the Deed of Appointment pursuant to the Nomad Trust dated 31st December 2001 appointing all rights, title and interests in Tern Inc and STV Inc held by the Nomad Trust to the new Makar Novus Trust is invalid and void.
8. An Order that the Deed of Appointment pursuant to the Nomad Trust dated 31st December 2001 appointing all rights, title and interests in Tern Inc and STV Inc held by the Nomad Trust to the new Makar Novus Trust be set aside.
9. Any other Order that this Honourable Court deems appropriate.

AND LET THE DEFENDANT within 14 days after service of this Summons on him counting the day of service, return the accompanying Acknowledgement of Service to the Courts Office.
