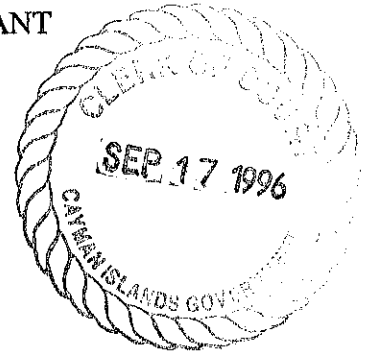

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgement may be entered against you forthwith without further notice.

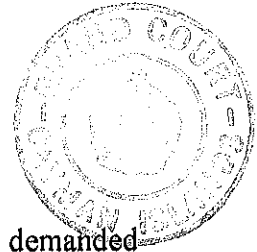

**Special Endorsement**

1. The plaintiff is business-man
2. The defendant is business-man who operates heavy equipment.
3. By letter dated the 3rd May, 1996, the plaintiff through his Attorneys, demanded the sum of \$6,583.00 from the defendant as monies due and owing for goods obtained on credit.
4. On the of 21st day of May, 1996 the defendant paid \$1,500.00 on the account and promised, in writing, to pay \$500.00 per week until the total amount was paid but he has failed to do so.



Wherefore the plaintiff Claims:-

- i. Balance due = \$5,083.00
- ii. Costs to be taxed or agreed.
- iv. Interest at Statutory rate.

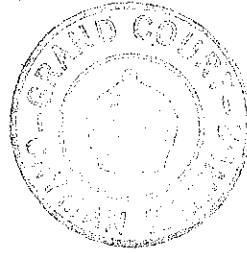
