WRIT OF SUMMONS

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within 14 days after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, PO Box 495G, George Town, Grand Cayman, the accompanying Acknowledgement of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

STATEMENT OF CLAIM

1. The Plaintiff was formerly known as Galleria Plaza Ltd. and was registered proprietor of that property registered in the Cayman Islands Land Registry as West Bay Beach South Block 12E Parcel 70 and known as Galleria Plaza Shopping Centre ("the shopping centre").
2. By a lease made on the 1st day of March 1983 between Galleria Plaza Ltd. and the Defendant, Galleria Plaza Ltd leased shop units number 1, 2 and 3 at the shopping centre to the Defendant at a rent of CI \$5,400.00 per month ("the lease").
3. As at 1 May 1993 the rent was in arrears of CI \$37,875.78.
4. Pursuant to Schedule 1 of the Lease, the Plaintiff further claims interest on the arrears of rent at the rate of 2.5% per month from 1 May 1993 until payment.

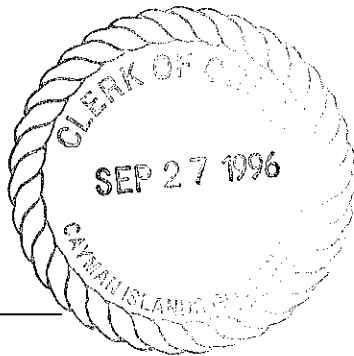
AND THE PLAINTIFF CLAIMS:-
