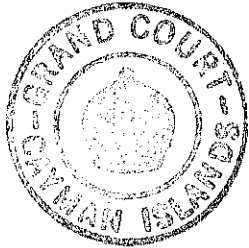


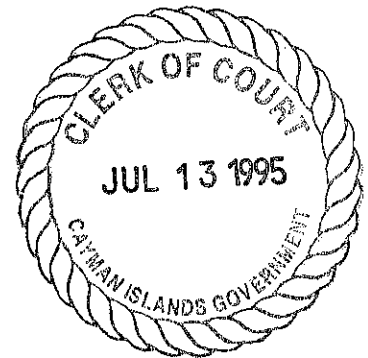

WRIT OF SUMMONS



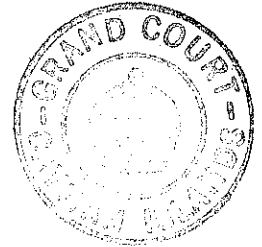

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within 14 days after the service of this Writ of Summons on you, counting the days of service, you must either satisfy the claim or return to the Courts Office, P.O. Box 495, George Town, Grand Cayman, the accompanying Acknowledgement of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

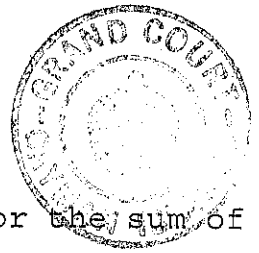

STATEMENT OF CLAIM



The Plaintiff's claim is against the Defendant for the sum of CI\$11,253.00 being the overdue balance on account in respect of goods supplied to the Defendant by the Plaintiff pursuant to a credit agreement.

PARTICULARS



1. The Plaintiff is a company duly incorporated under the Laws of the Cayman Islands to carry on business as suppliers of paint and other related sundries, having its registered office at Truman Bodden & Co., P.O. Box 866, George Town, Grand Cayman.
2. The Defendant is a company duly incorporated under the Laws of the Cayman Islands to carry on business as a construction company. Its registered office is Trident Trust Co. (Cayman) Ltd., P.O. Box 347, One Capital Place, George Town, Grand Cayman.
3. The Plaintiff's claim against the Defendant is for the overdue balance on account in respect of goods supplied by

the Plaintiff to the Defendant amounting to CI\$11,253.00 pursuant to a credit arrangement reached between the Plaintiff and the Defendant.

4. Pursuant to the agreement referred to in paragraph 3 hereof, between January 1992 and December 1993 the Plaintiff extended a line of credit to the Defendant under which the Defendant credited goods to the value of CI\$11,253.00.
5. The Plaintiff have periodically billed the Defendants through account statements reflects the cumulative balances to date of issue.
6. The Plaintiff and the Plaintiff's attorneys have made requests of the Defendant to settle this account. To date the Defendant has made no payments towards this debt and the amount of CI\$11,253.00 still remains due and owing.

AND THE PLAINTIFF CLAIMS:-

1. The sum of CI\$11,253.00;
2. Interest thereon pursuant to Section 62 (1) of the Judicature Law at the rate of 8 3/8 % per annum from the date of judgment until satisfaction.



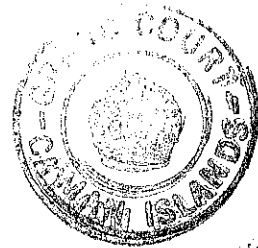
3. Fixed costs pursuant to Order 62 Rule 1 (b) of the Grand Court Rules, 1995 of CI\$250.00 together with costs of filing this Writ.

If, within the time for returning the Acknowledgement of Service, the Defendant pays the total amount claimed of CI\$2,097.31 plus interest and costs further proceedings will be stayed. The money must be paid to the Plaintiff or his attorney.

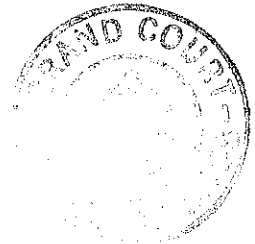

Notes on address for service

Attorney: where the Defendant is represented by an attorney, state the attorney's place of business in the Cayman Islands. A Defendant may not act by a foreign attorney.

Defendant in person: where the Defendant is acting in person, he must give his post office box number and the physical address of his residence or, if he does not reside in the Cayman Islands, he must give an address in Grand Cayman where communications for him should be sent. In the case of a limited company, "residence" means its registered or principal office.

Indorsement by plaintiff's Attorney (or by plaintiff if suing in person of his name, address and reference, if any, in the box below.

DIRECTIONS FOR ACKNOWLEDGMENT OF SERVICE
OF WRIT OF SUMMONS

1. The accompanying form of Acknowledgment of Service should be completed by an Attorney acting on behalf of the Defendant or by the Defendant if acting in person.

After completion it must be delivered or sent to the Law Courts, P.O. Box 495, George Town, Grand Cayman.

2. A Defendant who states in his Acknowledgment of Service that he intends to contest the proceedings must also serve a defence on the Attorney for the Plaintiff (or on the Plaintiff if acting in person).

If a Statement of Claim is indorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2), the Defence must be served within 14 days after the time for acknowledging service of the Writ, unless in the meantime a summons for judgment is served on the Defendant.

If the Statement of Claim is not indorsed on the Writ, the Defence need not be served until 14 days after a Statement of Claim has been served on the Defendant.

If the Defendant fails to serve his defence within the appropriate time, the Plaintiff may enter judgment against him without further notice.

3. A Stay of Execution against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgment is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to Question 3 in the Acknowledgment of Service, that he intends to apply for a stay, execution will be stayed for 14 days after his Acknowledgment, but he must, within that time, issue a Summons for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by installments or otherwise.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgment of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (the name stated on the Writ of Summons)".
4. Where the Defendant is a FIRM and an attorney is not instructed, the form must be completed by a PARTNER by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual TRADING IN A NAME OTHER THAN HIS OWN, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a LIMITED COMPANY the form must be completed by an Attorney or by someone authorised to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.
7. Where the Defendant is a MINOR or a MENTAL PATIENT, the form must be completed by an Attorney acting for a guardian ad litem.
8. A Defendant acting in person may obtain help in completing the form at the Courts Office.
