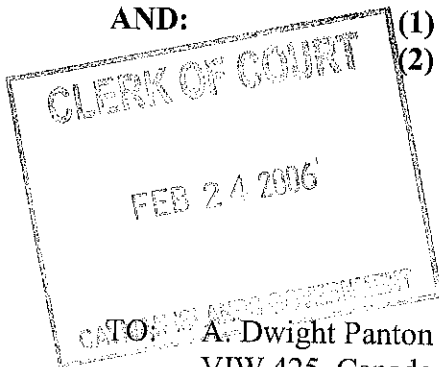

LET THE DEFENDANTS, within [14 days] after service of this Summons on them, counting the day of service, return the accompanying Acknowledgment of Service to the Courts office, PO Box 495G, George Town, Grand Cayman.

By this Summons, which is issued on the application of Robert Selkirk Watler III, Irene Watler and Lynette Watler the following Orders:-

1. That Robert Selkirk Watler III of P.O. Box 31189 SMB, Grand Cayman, Cayman Islands be appointed personal representative of the estate of the late Robert Selkirk Watler ("the Estate") in place of A. Dwight Panton;
2. That A. Dwight Panton do file accounts until the time of his replacement from the date he started as personal representative relating to the administration of the Estate pursuant to section 7 of the Succession Law (2004 Revision);
3. That A. Dwight Panton do cause all of the property of the Estate, whether real or personal to be registered in the name of Robert Selkirk Watler III as personal representative of the estate.

4. That the winding up of the Estate be executed under Court's direction in so far as may be necessary.

The Plaintiffs further claim that their costs in bringing these proceedings be paid out of the Estate.

If the Defendants do not acknowledge service, such judgment may be given or order made against or in relation to them as the court may think just and expedient.
