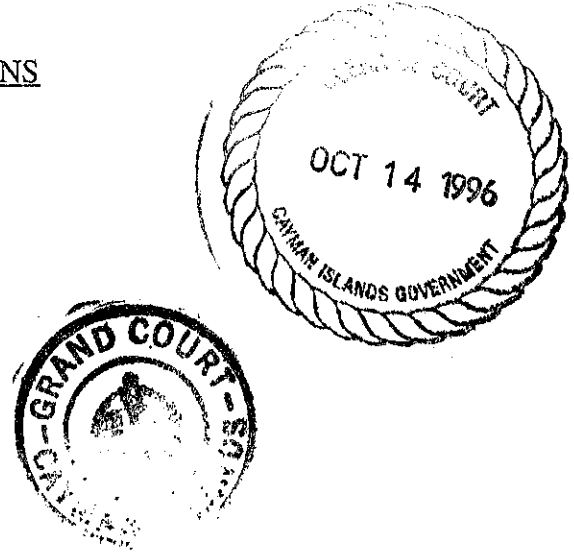

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within 14 days after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495G, George Town, Grand Cayman, the accompanying Acknowledgment of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

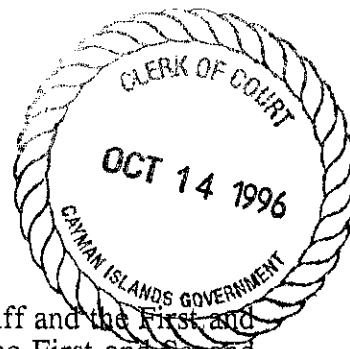

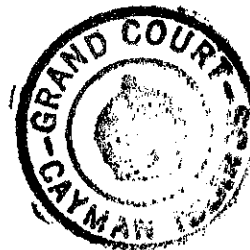


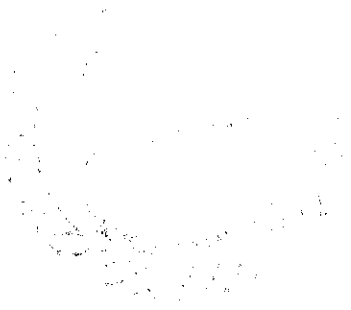
STATEMENT OF CLAIM

1. By a written agreement dated 27 June 1989 made between the Plaintiff and the First and Second Defendant ("the Agreement") the Plaintiff agreed to issue the First and Second Defendant with a credit token upon the terms and conditions therein set out.
2. The terms and conditions of the Agreement provided *inter alia* that:-
 - a. possession of the credit token entitles the First and Second Defendant to obtain cash advances and purchases of goods and services upon production thereof to such persons who honour the said credit token,
 - b. once a month the Plaintiff shall send a statement to the First and Second Defendant showing the account balance including any interest charged and the minimum payment to be made by the First and Second Defendant,
 - c. failure by the Defendants to pay the minimum monthly payment will result in the Defendants incurring late payment fees of \$20.00.
 - d. the First and Second Defendant shall repay to the Plaintiff on demand the whole of the outstanding balance owing on their account if either Defendant is in breach of any terms and conditions of the Agreement,
 - e. all outstanding account balances attract interest at the rate of 2% per month,
 - f. overdue accounts are subject to collection and all collection costs including, but not limited to, legal expenses incurred shall be charged to the Defendants' account.
3. The First and Second Defendant are in breach of the terms and conditions of the Agreement by consistently failing since 1 November 1994 to pay the minimum payments shown on the monthly statements sent to the First and Second Defendant.
4. The Plaintiff has made demand of the First and Second Defendant to repay the whole of the outstanding balance on their account without a satisfactory response.
5. The Plaintiff has incurred legal expenses prior to the issue of this writ of \$33.50 in trying to collect the Defendant's overdue account and claims these and all further legal expenses it incurs in connection with this action.

AND THE PLAINTIFF CLAIMS:-

1. The principal sum owing of \$3,085.13.
2. Legal expenses incurred to date of \$33.50.

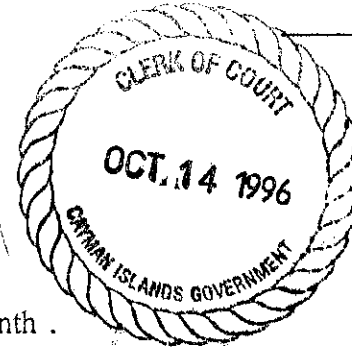




3. Late payment fees of \$230.00.
3. Interest accrued to 30 September 1996 at the rate of 2% per month of \$1,419.15, and continuing.
4. FURTHER and/or other relief.
5. COSTS of the Prescribed Filing and Bailiff Fees of \$160.00 and fixed costs \$250.00.

STATEMENT REGARDING INTEREST:

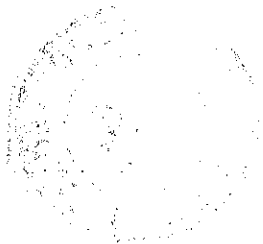
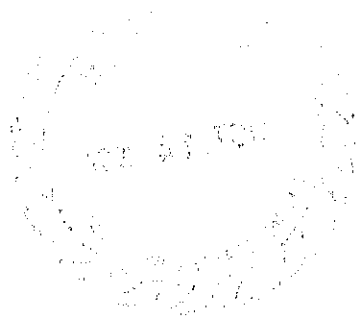
1. The rate of interest claimed is 2% per month .
2. The date from which interest is calculated is 1 November 1994 to 30 September 1996 as to CI\$3,085.13.
3. The total amount of interest claimed as at 30 September 1996 is CI\$1,419.15.
4. The amount of interest accruing each day thereafter is CI\$2.02.

If, within the time for returning the Acknowledgment of Service, the Defendant pays the total amount claimed of CI\$5,177.78 (including interest and costs) further proceedings will be stayed. The money must be paid to the Plaintiff's Attorney.

DIRECTIONS FOR ACKNOWLEDGMENT OF SERVICE
OF WRIT OF SUMMONS

1. The accompanying form of *Acknowledgment of Service* should be completed by an Attorney acting on behalf of the Defendant or by the Defendant if acting in person.

After completion it must be delivered or sent by post to the Law Courts, P.O. Box 495G, George Town, Grand Cayman.

2. A Defendant who states in his Acknowledgment of Service that he intends to contest the proceedings *must also serve a defence* on the Attorney for the Plaintiff (or on the Plaintiff if acting in person).

If a Statement of Claim is indorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2), the Defence must be served within 14 days after the time for acknowledging service of the Writ, unless in the meantime a summons for judgment is served on the Defendant.

If the Statement of Claim is not indorsed on the Writ, the Defence need not be served until 14 days after a Statement of Claim has been served on the Defendant.

If the Defendant fails to serve his defence within the appropriate time, the Plaintiff may enter judgment against him without further notice.

3. A *Stay of Execution* against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgment is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to Question 3 in the Acknowledgment of Service, that he intends to apply for a stay, execution will be stayed for 14 days after his Acknowledgment, but he must, within that time, *issue a Summons* for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by instalments or otherwise.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgment of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (*the name stated on the Writ of Summons*)".
4. Where the Defendant is a FIRM and an attorney is not instructed, the form must be completed by a PARTNER by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual TRADING IN A NAME OTHER THAN HIS OWN, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a LIMITED COMPANY the form must be completed by an Attorney or by someone authorised to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.
7. Where the Defendant is a MINOR or a MENTAL PATIENT, the form must be completed by an Attorney acting for a guardian *ad litem*.
8. A Defendant acting in person may obtain help in completing the form at the Courts Office.
