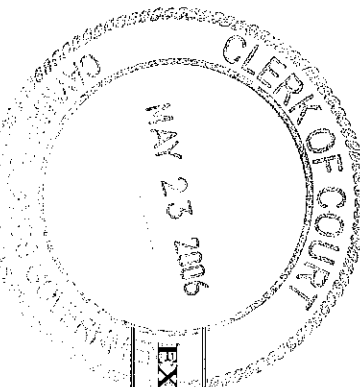


IN THE MATTER OF AN APPLICATION FOR AN ANTI-SUIT INJUNCTION

Embassy Investments Limited, a foreign company registered in the Cayman Islands with Company Number 130074, be restrained, whether by itself or by its servants or agents or otherwise howsoever, from commencing or continuing or prosecuting or assisting in the prosecution of any proceedings in the State of Texas or elsewhere other than in the Courts of the Cayman Islands directed to obtaining damages or other remedy whether under the Texas Deceptive Trade Practices Act or the Texas Insurance Code or otherwise arising from or relating to the Applicants' participations in the policies of insurance with slip reference numbers B05091DC435204, B05091DC435304, B05091DC435404 and MGMM-2004-039 providing coverage in respect of the Hyatt Regency Grand Cayman Resort or arising from or relating to the claim made by Embassy Investments Ltd under the said slip policies in respect of damage to the Hyatt Regency Grand Cayman Resort as a result of Hurricane Ivan.
2. Such other order be made as the Court considers fit.
3. The costs of this application be provided for.
