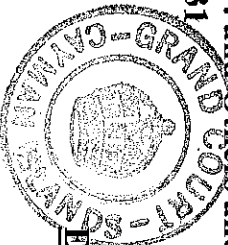

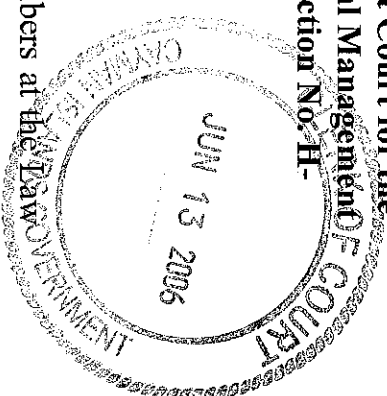

The Applicants are required by Order of the United States District Court for the Southern District of Texas, Houston Division, dated 30th December 2005, as modified by Order

dated 8th February 2006, to identify the individuals and entities who are investors and/or limited partners of the investment funds that purchased interests in the Enron bank debt at issue in Civil Action No. H-05-3031, and seek directions:-

1. that such identification be made pursuant to and in accordance with the said Order dated 30th December 2005 (modified as aforesaid), to the Defendants in Civil Action No. H-05-3031 viz JP Morgan Chase & Co, JP Morgan Chase Bank, N.A., JP Morgan Securities Inc, Citigroup Inc, Citibank N.A., and Citigroup Global Markets Inc, on a confidential basis in accordance with the Confidentiality Order dated 2nd February 2004 issued in the Texas proceedings.
2. that directions be given concerning the attendance of the said Defendants or by representatives on their behalf at the hearing of the application;
3. that directions be given concerning the attendance of the investors and limited partners, the disclosure of whose identity is required by the said Order, or by representatives on their behalf, who have indicated the wish to attend or to be represented at the hearing of this application;
4. and for such other directions as the Court may think fit.
