

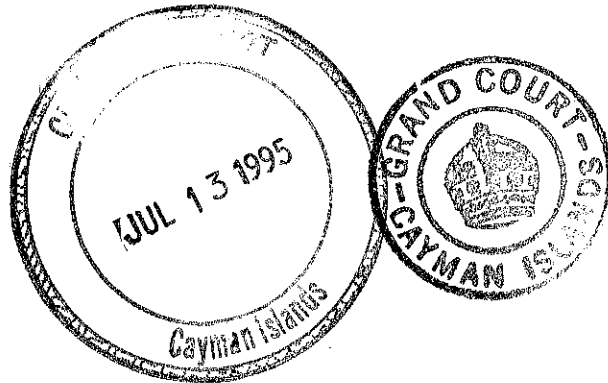

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

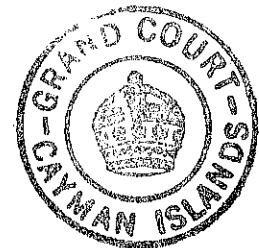
Within 14 days after the service of this Writ of Summons on you, counting the days of service, you must either satisfy the claim or return to the Courts Office, P.O. Box 495, George Town, Grand Cayman, the accompanying Acknowledgement of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

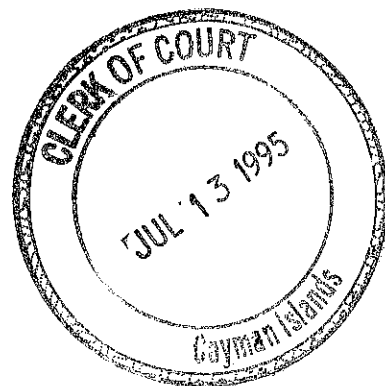

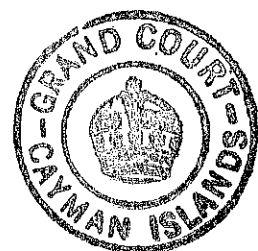


STATEMENT OF CLAIM

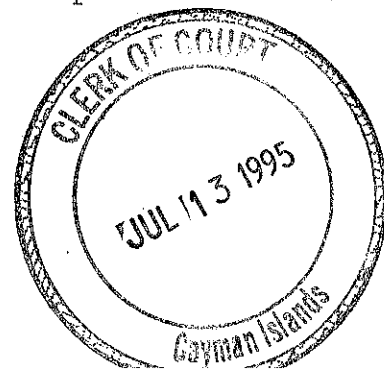
INDORSEMENT

The Plaintiff's claim is against the Defendant for the sum of CI\$4,264.50 being the balance due pursuant to an agreement dated the 15th day of November, 1994 whereby the Plaintiff granted to the Defendant a license for use of its' premises, the Lions Centre, on the 31st day of December, 1994.

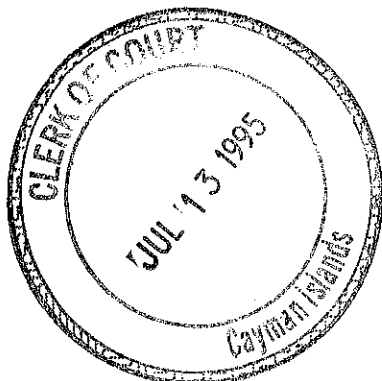
PARTICULARS



1. The Plaintiff is a charitable organisation duly licensed by the Governor of the Cayman Islands as an association not for profit whose address for service is P.O. Box 1400 G, Lions Centre, Red Bay, Grand Cayman.
2. The Defendant is a person resident in the Cayman Islands who operates a business venture known as On Stage Productions and whose address for service is P.O. Box 30317 SMB, Grand Cayman.
3. By an agreement in writing dated the 15th day of November, 1994 the Plaintiff granted the Defendant a license for use of the Lions Centre to stage a live musical production on 31st December, 1994 ("the Agreement").



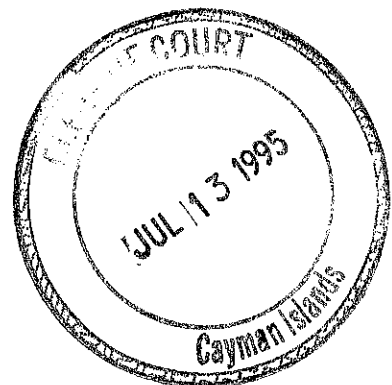
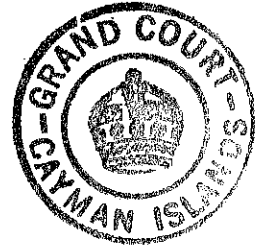
4. Pursuant to the agreement, the Defendant in consideration for grant of the said license would pay the Plaintiff CI\$10,000.00.
5. By an addendum to the Agreement also dated 15th November, 1994 "the Addendum" the Plaintiff and the Defendant agreed specific dates for payment of installments of the said sum of CI\$10,000.00.
6. Paragraph 1 of the said Addendum required the Defendant to make payments pursuant to the following payment schedule:-
  - (i) CI\$1,000.00 on the 5th day of November, 1994;
  - (ii) CI\$1,500.00 on the 1st day of December, 1994; and
  - (ii) CI\$7,000.00 on the 31st day of December, 1994.
7. Pursuant to the said payment schedule the Defendant paid to the Plaintiff the sum of CI\$1,000.00 on the 15th day of November, 1995 and the sum of CI\$1,500.00 on the 1st day of December, 1994.
8. In contravention of the said payment schedule the Defendant failed to pay the full amount of CI\$7,500.00 due on the 31st day of December, 1994 in final payment of the said contract.



9. On the 31st day of December 1994, the Defendant paid the Plaintiff the sum of CI\$3,235.50 in part payment of the remaining balance of CI\$7,500.00.
10. Despite demands for payment made by the Plaintiff and the Plaintiff's Attorney-at-Law the Defendant has failed to pay the sum of CI\$4,264.50 being the balance due pursuant to the Agreement.

AND THE PLAINTIFF CLAIMS:-

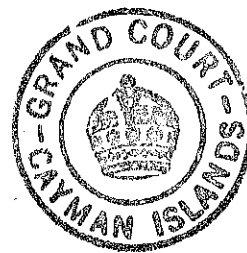
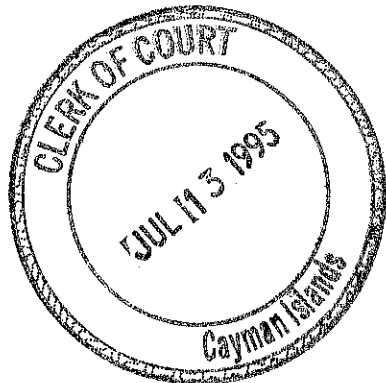
1. The said sum of CI\$4,264.50;
2. Interest thereon pursuant to Section 62 (1) of the Judicature Law at the rate of 8 3/8 % per annum from the date of judgment until satisfaction.
3. Fixed costs pursuant to Order 62 Rule 1 (b) of the Grand Court Rules, 1995 of CI\$250.00 together with costs of filing this Writ of CI\$100.00.



If, within the time for returning the Acknowledgement of Service, the Defendant pays the total amount claimed of CI\$4,264.50 plus interest and costs further proceedings will be stayed. The money must be paid to the Plaintiff or his attorney.

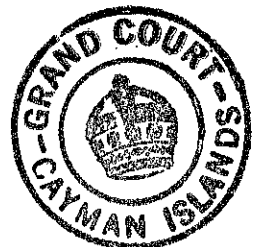

Notes on address for service

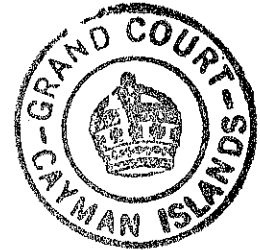
Attorney: where the Defendant is represented by an attorney, state the attorney's place of business in the Cayman Islands. A Defendant may not act by a foreign attorney.

Defendant in person: where the Defendant is acting in person, he must give his post office box number and the physical address of his residence or, if he does not reside in the Cayman Islands, he must give an address in Grand Cayman where communications for him should be sent. In the case of a limited company, "residence" means its registered or principal office.

DIRECTIONS FOR ACKNOWLEDGMENT OF SERVICE  
OF WRIT OF SUMMONS

1. The accompanying form of Acknowledgment of Service should be completed by an Attorney acting on behalf of the Defendant or by the Defendant if acting in person.

After completion it must be delivered or sent to the Law Courts, P.O. Box 495, George Town, Grand Cayman.

2. A Defendant who states in his Acknowledgment of Service that he intends to contest the proceedings must also serve a defence on the Attorney for the Plaintiff (or on the Plaintiff if acting in person).

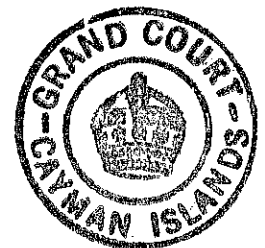
If a Statement of Claim is indorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2), the Defence must be served within 14 days after the time for acknowledging service of the Writ, unless in the meantime a summons for judgment is served on the Defendant.

If the Statement of Claim is not indorsed on the Writ, the Defence need not be served until 14 days after a Statement of Claim has been served on the Defendant.

If the Defendant fails to serve his defence within the appropriate time, the Plaintiff may enter judgment against him without further notice.

3. A Stay of Execution against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgment is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to Question 3 in the Acknowledgment of Service, that he intends to apply for a stay, execution will be stayed for 14 days after his Acknowledgment, but he must, within that time, issue a Summons for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by installments or otherwise.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgment of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (the name stated on the Writ of Summons)".
4. Where the Defendant is a FIRM and an attorney is not instructed, the form must be completed by a PARTNER by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual TRADING IN A NAME OTHER THAN HIS OWN, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a LIMITED COMPANY the form must be completed by an Attorney or by someone authorised to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.
7. Where the Defendant is a MINOR or a MENTAL PATIENT, the form must be completed by an Attorney acting for a guardian ad litem.
8. A Defendant acting in person may obtain help in completing the form at the Courts Office.
