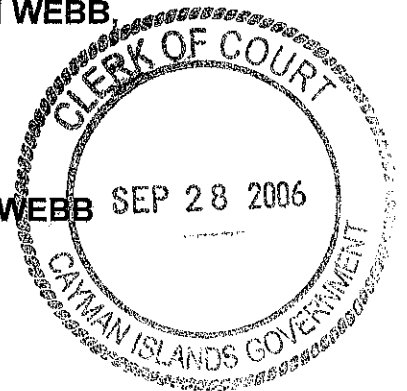


ORIGINATING SUMMONS
