Box 495 GT, George Town, Grand Cayman, the accompanying Acknowledgment of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

Issued this 11th day of October 1996.

NOTE - This Writ may not be served later than 4 calendar months (*or, if leave is required to effect service out of the jurisdiction, 6 months*) beginning with the date of issue unless renewed by order of the Court.

## STATEMENT OF CLAIM

1. The Plaintiff claims CI\$5133.09 from the Defendant for Medical Expenses.
2. Between 19th April 1993 and 29th August 1996 the Defendant incurred Medical Expenses in the amount of CI\$5133.09 for services rendered by the Health Services of the Cayman Islands.
3. This debt became due and payable at the time the services were rendered.
4. The Health Services Department wrote to the Defendant on two occasions requesting payment.
5. The Treasury Debt Collector wrote to the Defendant on 13th, September, 1996 requesting payment but this debt remains unpaid.

AND THE PLAINTIFF claims:

1. The sum of CI\$5133.09
2. Interest at the statutory rate of 7 3/8%
3. Fixed cost of CI\$150.00, alternatively costs to be assessed.



If, within the time for returning the Acknowledgment of Service, the Defendant pays the total amount claimed further proceedings will be stayed. The money must be paid to the Plaintiff.

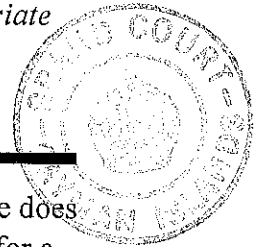
