

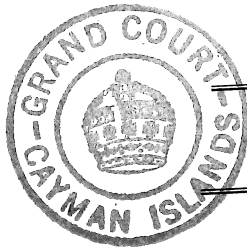

LET ALL PARTIES CONCERNED attend before the Judge in Chambers at the Law Courts, George Town, Grand Cayman on the 22 day of February 2007 at 9:30 a.m. on the hearing of an application by the Joint Voluntary Liquidators (the "JVLs") of Bridge Investment Holding Limited (in Voluntary Liquidation) (the "Company") pursuant to s. 141 of the Companies Law (2004 Revision) for the following orders and/or directions:

- 1) That the funds held in the bank accounts listed in Schedule "A" attached hereto (the "Trust Accounts") are held on trust for certain beneficiaries (the "Beneficiaries") and in the amounts listed in Schedules "B" to "E" attached hereto; and
- 2) Approval of the actions undertaken, or to be undertaken, by the JVLs to locate the Beneficiaries as set out in the affidavit of Stuart Sybersma filed herein; and
- 3) The JVLs retain in the Trust Accounts any funds due to Beneficiaries whose whereabouts cannot be discovered by the JVLs, and thereafter administer the Trust

Accounts in accordance with the terms contained in the affidavit of Stuart Sybersma filed herein; and

- 4) That the costs of this Originating Summons be costs in the voluntary liquidation of the Company.
