
ORIGINATING SUMMONS

- 3 Such further and/or other relief as this Honourable Court shall deem appropriate.

AND LET THE DEFENDANT within 14 days after the service of this summons on him/her counting the day of service return the accompanying Acknowledgement of Service to the Courts Office.
