LET THE RESPONDENT attend before a Judge of the Grand Court in Chambers at the Law Courts, George Town, Grand Cayman on the day of 2007 at o'clock in the fore/afternoon on the hearing of an application by the Applicants who seek the determination of the Court on the following question, namely an Order:-

1. That the Applicants be appointed guardians for the said Emmeline Jane Minzet aka Emmeline Minzett (“the Patient”) and over her estate and effects with the following powers conferred upon them:-
 - a) to control and manage the properties of the Patient.
 - b) to sell, acquire, charge or otherwise dispose of or deal with any properties of the Patient.
 - c) to pay from the proceeds of sale such sum or sums required to discharge the charges registered over the Property Lower Valley Block 37A, Parcel 2 in favour of the Civil Service Co-Operative Credit Union Limited.
 - d) to invest the proceeds of sale or any other monies belonging to the Patient in such securities as the Applicants for the time being are authorized by law to invest in trust funds.
 - e) to deposit into and withdraw from any account at any bank or lending institution in the Cayman Islands and elsewhere such of the Patient’s monies as may be necessary for the proper maintenance and care of the Patient.
2. That the Applicants be appointed Receivers in relation to the administration of the estate of the Patient.
3. That the Applicants shall keep proper accounts of the administration and management of the property of the Patient and whenever required by the Court to do so shall file in Court copies of such accounts.

4. That the cost of this application and the cost of the guardian and receiver incidental to and consequent upon the Order shall be paid from the estate and property of the Patient.

DIRECTIONS FOR ACKNOWLEDGMENT OF SERVICE

The accompanying form of *Acknowledgment of Service* should be completed by an Attorney acting on behalf of the Defendant or by the Defendant if acting in person. After completion it must be delivered or sent by post to the Law Courts, P.O. Box 495, Grand Cayman KY1-1106, Cayman Islands.

Notice for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgment of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words “sued as (*the name stated on the Originating Summons*)”.
4. Where the Defendant is a FIRM and an attorney is not instructed, the form must be completed by a PARTNER by name, with the addition in paragraph 1 of the description “Partner in the firm of (.....)” after his name.
5. Where the Defendant is sued as an individual TRADING IN A NAME OTHER THAN HIS OWN, the form must be completed by him with the addition in paragraph 1 of the description “trading as (.....)” after his name.
6. Where the Defendant is a LIMITED COMPANY the form must be completed by an Attorney or by someone authorized to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.



Notes on address for service

Attorney: where the Defendant is represented by an attorney, state the attorney's place of business in the Cayman Islands. A Defendant may not act by a foreign attorney.

Defendant in person: where the Defendant is acting in person, he must give his post office box number and the physical address of his residence or, if he does not reside in the Cayman Islands, he must give an address in Grand Cayman where communications for him should be sent. In the case of a limited company, "residence" means its registered or principal office.
