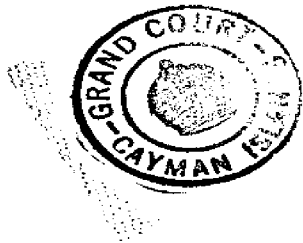

ORIGINATING SUMMONS

LET THE DEFENDANTS, whose address for service is c/o Maples and Calder, Uglan House, George Town, Grand Cayman KY1-1104 attend before the Judge in Chambers, at the Law Courts, George Town, Grand Cayman on the 19 day of July 2007 at 11

o'clock on the hearing of an application by the Plaintiffs for orders that in respect of each of the Causes and Members' Voluntary Liquidations listed in the Appendix hereto (the "Liquidations"):

1. Mr. Hugh Dickson is appointed as a Joint Liquidator for the purposes of:
 - a. Communicating with creditors as to matters relating to the liquidation following the First Defendant's resignation as a partner of RSM Cayman Islands and the Second Defendant's resignation as an employee of RSM Cayman Islands;
 - b. Ensuring the orderly management of the liquidation;
 - c. Applying for further directions from the Court;
2. In the case of a Court supervised liquidation, the Second Plaintiff, the First Defendant and the Second Defendant (the "Liquidators") are instructed to provide a copy of this Order to each known creditor in the liquidation and to inform the creditors that a further directions hearing will take place at 10 o'clock on 3 August 2007 (the "Combined Directions Hearing").
3. In the case of a Members' Voluntary liquidation, the Second Plaintiff, the First Defendant and the Second Defendant (the "Liquidators") are instructed to provide a copy of this Order to each member and to inform the members of the Combined Directions Hearing.
4. The Liquidators are to continue to engage RSM Cayman Islands, the First Plaintiff and the staff of RSM Cayman Islands in the conduct of the Liquidation until further order.
5. The Liquidators are not to engage RSM Cayman Islands Limited, the Third Defendant, until further order.

6. Time for service of this Originating Summons be abridged to 1 hour.
7. The costs of this application are reserved to the Combined Directions Hearing.
8. Liberty to apply on 3 clear working days' notice.
