THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within [14 days] after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P. O. Box 495 GT, George Town, Grand Cayman, the accompanying Acknowledgment of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

STATEMENT OF CLAIM

1. The Plaintiff claims CI\$20,951.44 from the Defendant for overseas medical expenses.
2. On the 17th June 1998 the Defendant signed a promissory note agreeing to repay the Cayman Islands Government for all expenses paid for Rejuan Miguel Henry to be treated at the Baptist Hospital of Miami on or around the 19th June, 1998.
3. Rejuan Miguel Henry overseas medical expenses amounted to CI\$21,551.44.
4. The Defendant signed an agreement to pay CI\$250.00 per month.
5. The Cayman Islands Health Services Authority and the Debt Recovery Unit communicated with the Defendant on numerous occasions, requesting payment.
6. No payments have been made recently by the Defendant. The balance of CI\$20,951.44, still remains unpaid.

AND THE PLAINTIFF claims:

1. The sum of CI\$20,951.44.
2. Interest at the statutory rate of 3%
3. Process Server's fee
3. Fixed cost of CI\$500.00, alternatively costs to be assessed.

If, within the time for returning the Acknowledgment of Service, the Defendant pays the total amount claimed further proceedings will be stayed. The money must be paid to the Plaintiff.
