

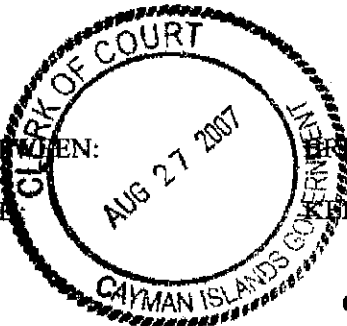

ORIGINATING SUMMONS

LET ALL PARTIES CONCERNED, attend before a Judge in Chambers, at the Law Courts, George Town, Grand Cayman on the day of 2007, at o'clock on the hearing of an application by the Plaintiff for the following Orders:-

1. That the Defendant be restrained, whether by himself or his agents or servants, from in any way assaulting, molesting, interfering, annoying or troubling the Plaintiff as she goes about her business until further Order of this Court.
2. That the Defendant be restrained from approaching within 100 yards of the Plaintiff or her place of residence at No. 6 Crystal Valley Crescent, West Bay, Grand Cayman, or at her place of work at Anderson Square, George Town, Grand Cayman until further Order of this Court.
3. That the Defendant has liberty to apply within 14 days.
4. That the Defendant pays the costs of this application.
5. That there be such further Order as this Court deems just in the circumstances.
6. That there be penal consequences in the event of a breach of this Order.

AND LET THE DEFENDANT within 14 days after service of this summons on him counting the day of service, return the accompanying Acknowledgment of Service to the Courts office.

NOTES:-

- (1) This Summons may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the above date unless renewed by order of the Court.
- (2) If a defendant does not attend personally or by his attorney at the time and place above-mentioned such order will be made as the Court may think just and expedient.

In the case of a limited company, "residence" means its registered principal office.
