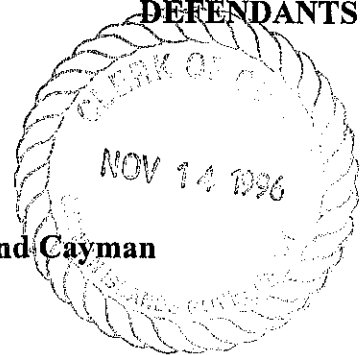

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within 14 days after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495G, George Town, Grand Cayman, the accompanying Acknowledgement of Service stating therein whether you intend to contest these proceedings.

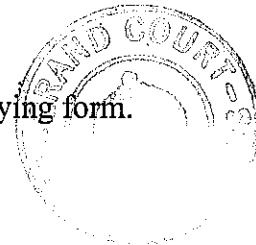
If you fail to satisfy the claim or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

Issued this 14th day of November 1996.

NOTE - This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by order of the Court.

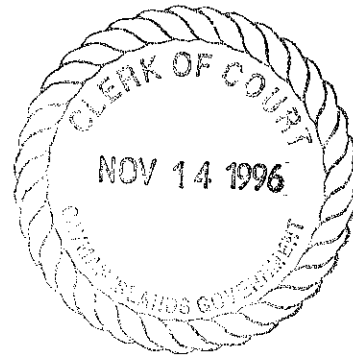
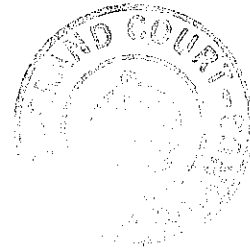
STATEMENT OF CLAIM

1. Pursuant to the terms of a charge dated the 11th June 1986 the Defendant agreed to repay the Plaintiff the sums borrowed by the Defendant from the Plaintiff together with interest on demand.
2. Despite demand the Defendant has failed to pay the full amount due and owing under the charge and the sum of CI\$32,198.72 remains due and owing by the Defendant to the Plaintiff.

AND THE PLAINTIFF CLAIMS:

1. The said sum of CI\$32,198.72;
2. Interest pursuant to Section 34(1) of The Judicature Law (1995 revision) at 7 3/8% per annum at a daily rate of CI\$6.51 per day.
3. Costs.
