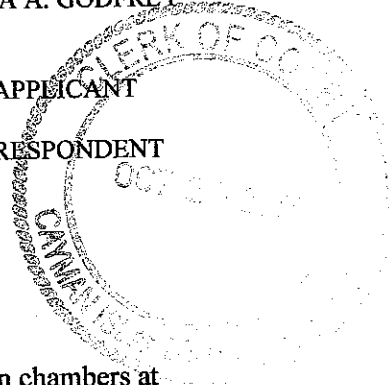

**EX PARTE ORIGINATING SUMMONS**


LET ALL PARTIES CONCERNED attend before a Judge of the Grand court in chambers at

in the fore/afternoon on the hearing of an application by the Applicant for the following order(s)  
and other relief :-

1. That service of Summons on the Respondent be dispensed with.
2. That the applicant be appointed guardians for the said PRISCILLA GODFREY AKA PRISCILLA ADITHA GODFREY AKA PRISCILLA A GODFREY ('the patient') and over her estate an effects with the following powers conferred upon her.
  - a) to control and manage the property of the patient.
  - b) to sell, acquire, charge or otherwise dispose of or deal with any property of the patient.
  - c) to invest the proceeds of sale or any other monies belonging to the patient in such securities as the Applicant for the time being are authorized by law to invest trust funds.
  - d) to deposit into and withdraw from any account at any bank or lending institution in the Cayman Islands and elsewhere such of the patient's monies as may be necessary for the proper maintenance and care of the patient.
3. That the Applicant be appointed Receiver in relation to the administration of the estate of the patient.
4. That the Applicant shall keep proper accounts of the administration and management of the property of the patient and whenever required by the Court to do so shall file in court copies of such accounts.



5. That the cost of this application and the cost of the guardian and receiver incidental to and consequent upon the Order shall be paid from the estate and property of the patient.
