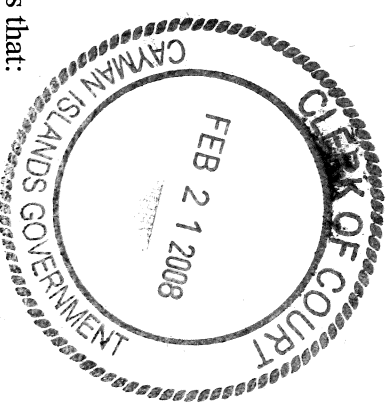

The Humble Petition of Dimitrios Aravanis, (the "Petitioner") shows that:

1. The Petitioner is a Canadian resident and an unsatisfied creditor of FOCUS MANAGEMENT INC. ("Focus").
2. Focus is a Cayman Islands exempted limited liability company organised and incorporated on May 4<sup>th</sup>, 1990.
3. Focus' registered office is situated at c/o Caledonian Trust (Cayman) Limited, P.O. Box 1043, Caledonian House, First Floor, 69 Dr. Roys Drive, Grand Cayman, CAYMAN ISLANDS.
4. Focus' share capital is US\$900,000.00 divided into 900,000 shares of a nominal or par value of US\$1.00 each. The issued share capital is 2 shares.  
The objects for which Focus was established are unrestricted.

5. Focus is indebted to the Petitioner for the principal sum of CAD49,548.15, plus interest at the annual rate of 9% on from 1 July 2004. As at 30 of June, 2007 the amount of capital and interest outstanding was CAD64,166.29.
6. The following facts and particulars are relied upon in support of the Petition:
  - (i) On 25 March 2004 the Petitioner consulted with Mr. Themistoklis Papadopoulos (“Papadopoulos”), a representative of Triglobal Capital Management Inc. (“Triglobal”), an investment firm, registered and located in the Province of Quebec, Canada, regarding an investment. The Petitioner was advised to invest, through a loan facility, in Focus;
  - (ii) The meeting took place at Triglobal’s place of business located at 1304, Greene Street, Montreal, Quebec, Canada;
  - (iii) Triglobal is indirectly owned by Mr. Mario Bright (“Bright”) and Papadopoulos, both Canadian Residents. Papadopoulos is the president of Triglobal;
  - (iv) Focus is 100% beneficially owned by Bright and Papadopoulos. Its operations address is P.O Box 30440, Windward 1, Safehaven, WB Road, Grand Cayman KY1-1202, Cayman Islands;
  - (v) On Papadopoulos’ advice, the Petitioner loaned CAD49,548.15 to Focus pursuant to an agreement numbered P-AFIL-3943 commencing 1 July 2004;
  - (vi) The agreement provided that the duration of the loan was 36 months and the principal and interest would be repaid at maturity;

(vii) The term of the loan expired on 30 June 2007 and demand for repayment was made on 30 June 2007; and,

(viii) As at the date hereof, despite numerous demands to do so, Focus has failed to pay the principle sum of CAD49,548.15 or interest or any part thereof.


7. In the circumstances, Focus should be wound up on the basis that it is unable to pay its debts as they fall due, alternatively that it is just and equitable to do so.

**YOUR PETITIONER THEREFORE HUMBL Y P R A Y S T H A T:**

- (1) Focus be wound up by the Court under the provisions of the Companies Law (2007 Revision).
- (2) That one or more Official Liquidator(s) be appointed for Focus on such terms as the Court may think fit.
- (3) That the costs of and incidental to the Petition be an expense of the liquidation of Focus.
- (4) Such further and/or other relief as the Court thinks fit.
