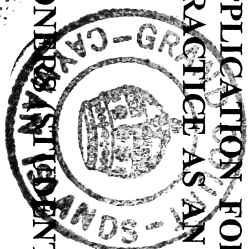

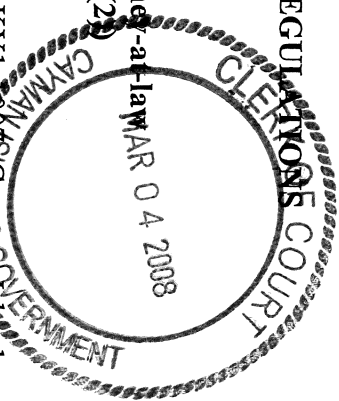

LEGAL PRACTITIONERS (ARTICLES) REGULATIONS COURT

(2007 Revision)

Application to be Admitted as an Attorney-at-law (AR 04 2008)
(section 3(1)(c) and regulation 19(2))



We Gregory Thompson of P.O. Box 10920, Grand Cayman KY1-1001, Cayman Islands and Christopher Humphries of P.O. Box 2510, Grand Cayman KY1-T104, Cayman Islands do solemnly and sincerely declare as follows:

A. And I the said Gregory Thompson for myself do say that:

- (1) I am one and the same person named as clerk in the Articles of Clerkship bearing the date the 1st day of March, 2007 now produced and shown to me marked with the letter "A" (the "Articles of Clerkship").
- (2) The said Articles of Clerkship were registered pursuant to regulation 16 on the 10 day of April, 2007.
- (3) Since the date of execution of the Articles of Clerkship I have been actually employed in the proper business practice and employment of Stuarts Walkers Hersant, Attorneys-at-Law and have not held any other office or engaged in any other employment during that period.
- (4) I have never been convicted of a criminal offence.
- (5) I was awarded a Certificate from the Legal Advisory Council on the 16 day of September, 2005, and a true copy of the same is now produced and shown to me marked with the letter "B".
- (6) I was granted an abridgement of 6 months to my term of Articles of Clerkship on the 9 day of May, 2007, and a true copy of the same is now produced and shown to me marked with the letter "C".

B. And I the said Christopher Humphries for myself do say:

(1) I am a practising attorney-at-law qualified under section 15 of the Legal Practitioners Law (2007 Revision) to take a person into my service as an Articled Clerk, and am the same person named as principal in the Articles of Clerkship now produced and shown to me marked with the letter "A".

(2) The said Gregory Thompson has been bound by articles to me since the 1 day of March, 2007, and has since that date been employed in my proper business practice and employment as an Articled Clerk.

(3) The period of articles which has been served satisfies the requirement of regulation 17.

(4) The said Gregory Thompson is a fit and proper person to be admitted as an attorney-at-law.

And we make this solemn declaration conscientiously believing the same to be true and by virtue of the Voluntary Declarations Law (1998 Revision).
